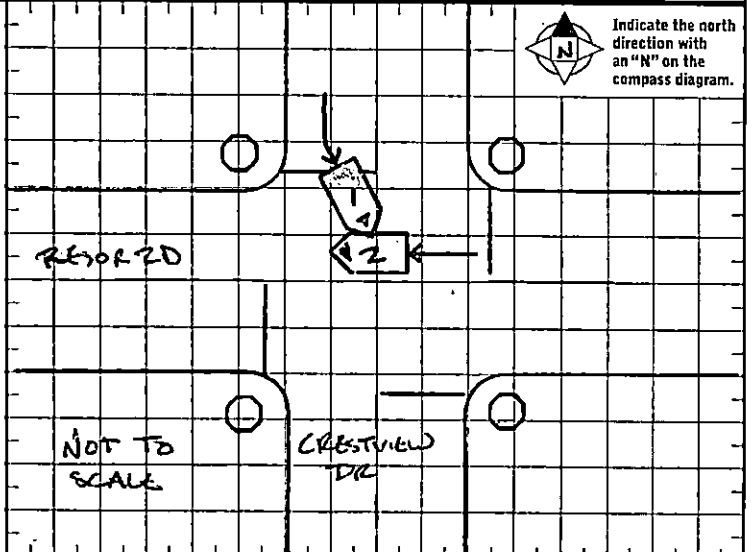

NARRATIVE

On 5/3/2022 at about 4:16 p.m. Unit 1 was traveling south on Crestview Dr. attempting to make a left turn to travel east on Resor Rd. and in so doing collided with Unit 2 which was traveling west on Resor Rd.

The driver of Unit 1 stated the driver of Unit 2 failed to stop for the stop sign at Cresview Ave. The driver of Unit 2 stated she arrived at the four way stop before Unit 1 and had the right of way at the intersection.

There were no independent witnesses to the crash and no video footage was available. No determination was made on which unit was in error.
