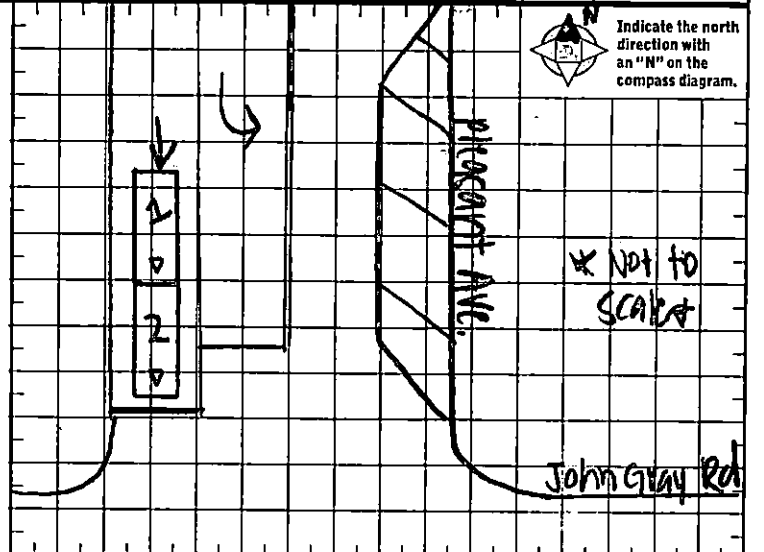

NARRATIVE

On 05/05/22 at around 10:22 p.m., Unit 1 was traveling southbound on Pleasant Ave. at approximately 40 m.p.h. and when at John Gray Rd., failed to stop within the assured clear distance ahead. In doing so, Unit 1 collided with Unit 2, which was also traveling southbound and was stopped in traffic on Pleasant Ave. at John Gray Rd. Brake lights on Unit 2 were inspected and working properly.

The driver of Unit 1, Terrina Heim, was also charged with OVI (FCO 333.01a1A & FCO 333.01a2) - M1, and Leaving the Scene of the Accident (FCO 335.12a) - M1.

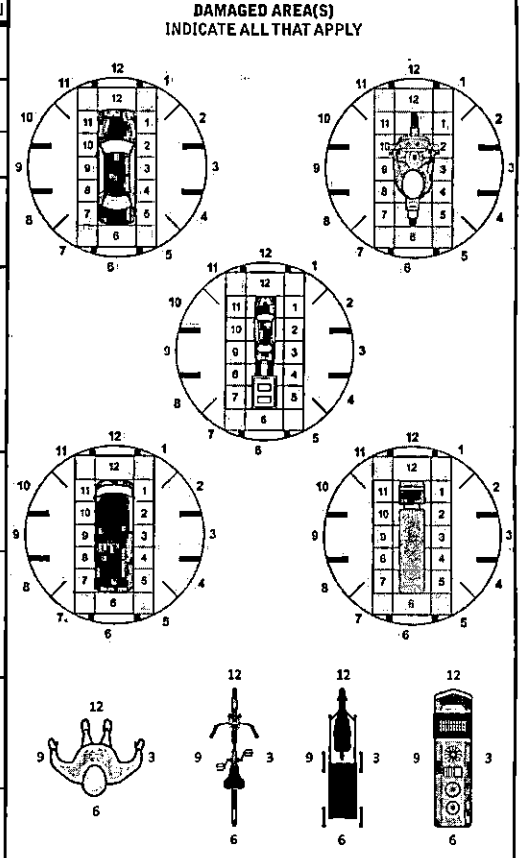
