

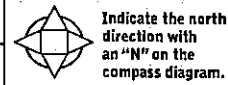

When Unit 2 struck the passenger side of Unit 1 while Unit 1 was turning on to Diversion Rd. The driver of Unit 1 did not know which lane Unit 2 was traveling at the time before the crash.  On 09-19-22 at 7:19 a.m., the driver of Unit 2 stated that Unit 2 was traveling south on SR4 By-pass in the left hand right turn lane. Unit 1 was traveling in the straight through lane, when Unit 1 came over into the left hand right turn lane of the intersection to make a right turn causing Unit 1 to strike Unit 2 in the driver side front area.
