On 11/18/2022 at 4:07 p.m., Unit 1 was traveling east on Vinnedge Ave. and when at 4828 Redwood Dr. went off the roadway right and in so doing collided with Unit 2. Unit 1 then backed up, pulled forward and struck Unit 3 and Unit 4 which were all parked in the driveway of 4828 Redwood Dr. Unit 1 then backed down Vinnedge Ave. and struck a fire hydrant in front of 470 Vinnedge Ave. Unit 1 then continued backwards down Vinnedge Ave. and collided with Unit 5, which was parked in the driveway of 427 Vinnedge Ave. The fire hydrant belongs to City Of Fairfield, 5350 Pleasant Ave, Fairfield, OH 45014. Their phone number is (513) 867-5318. Unit 1 was also charged with Hit and Run F.C.O. -335.12A(1).
