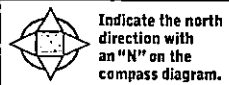

NARRATIVE

On 12/12/22 at around 10:26 p.m., Unit 2 was facing southbound and stopped at the traffic light on Pleasant Ave. at Nilles Rd. Unit 2 began traveling southbound when the traffic light turned green. At the time, Unit 1 was traveling eastbound on Nilles Rd. When at the intersection of Nilles Rd. and Pleasant Ave., Unit 1 failed to obey the traffic control device and ran the red light. In doing so, Unit 2 collided with Unit 1. Unit 1 continued east flipped onto its roof and collided with the traffic light pole at the southwest corner of the intersection. The vehicle came to rest on Nilles Rd. in front of 5214 Pleasant Ave., Fairfield, OH.

The driver of Unit 1, David Alvorado Atz, was cited for No O/L (FCO 335.01a1) - M1.

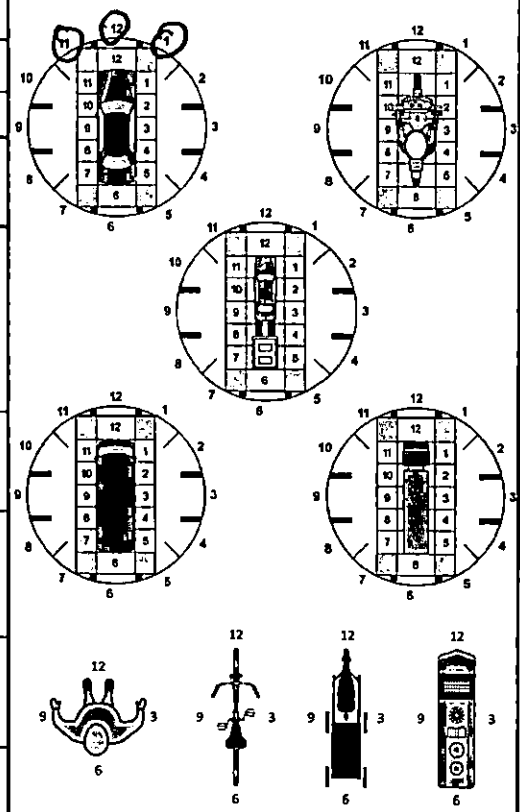

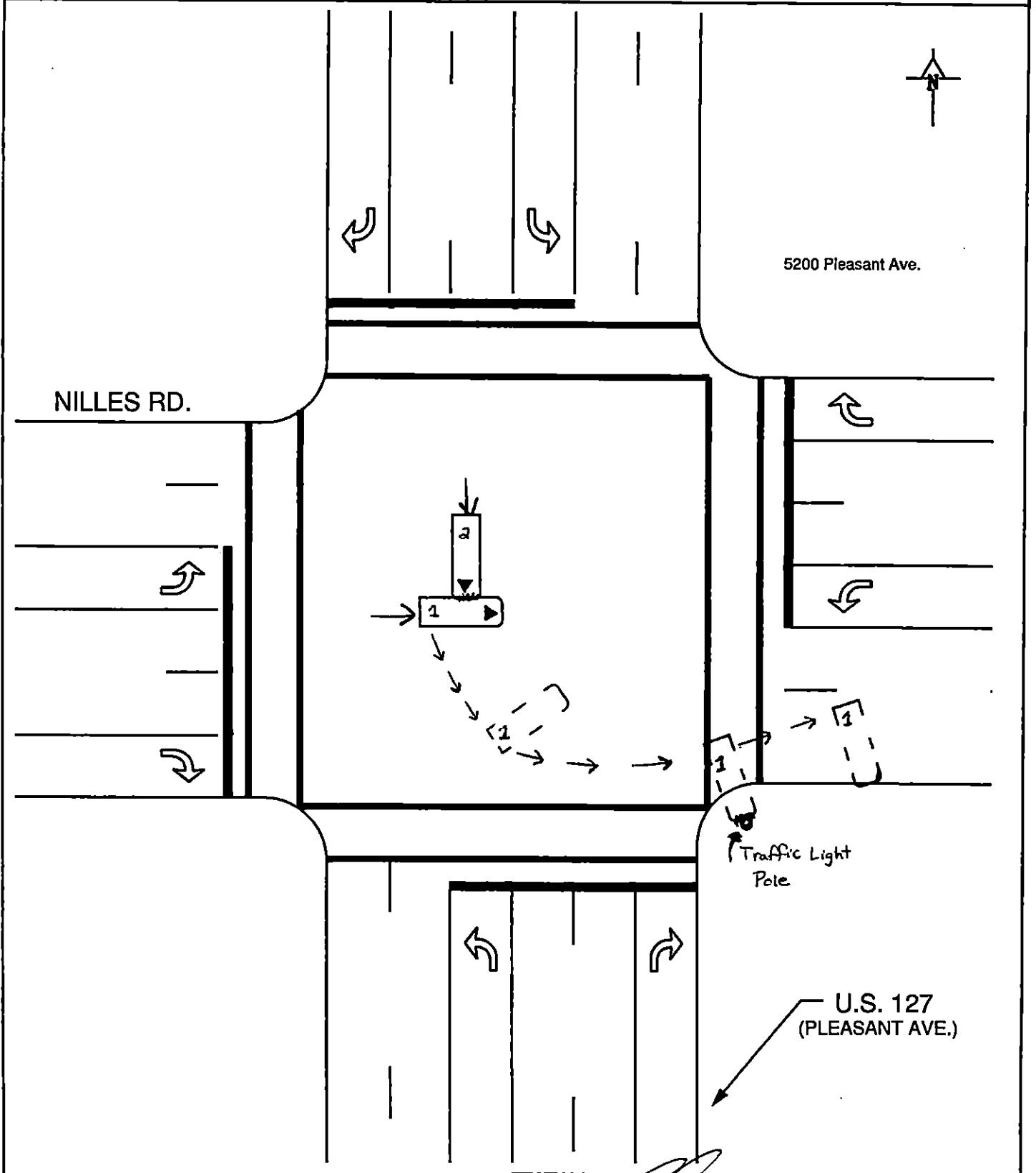
