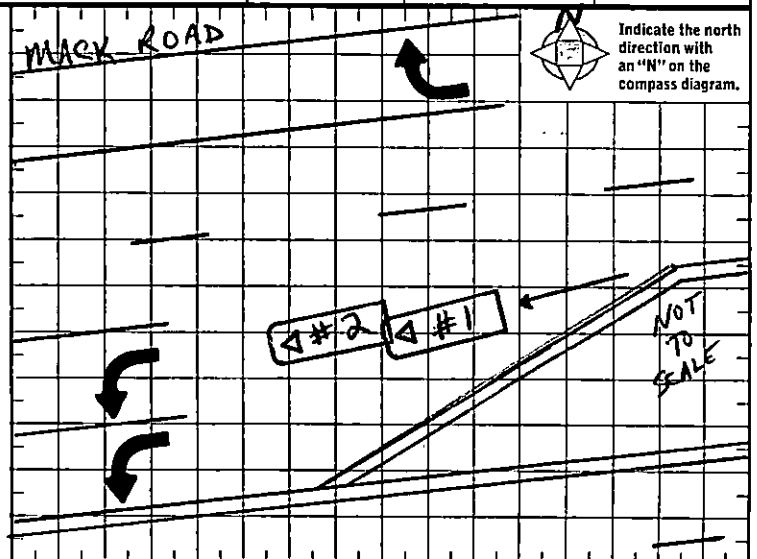

NARRATIVE

On January 30, 2023 at about 12:30 P.M. Unit 1 was traveling west on Mack Rd. at approximately 35 m.p.h. and failed to stop within the assured clear distance ahead and collided with Unit 2 which was also traveling westbound at approximately 25 m.p.h. on Mack Road.

Both vehicle were moved from the accident location and there was no debris to determine the exact location of the accident.
