On February 4, 2023, at 4:02 P.M., unit 1 was traveling south on Seward Road near house number 8105. As unit 1 approached a bend in the roadway, they failed to maintain reasonable control of the vehicle before running off the road right and struck the ditch. Unit 1 then attempted to correct their vehicle and flipped it approximately two times before going off the roadway left and coming to rest on its side in the ditch. Unit 1 driver was transported by squad to a local hospital for suspected minor injuries.	See OH-2

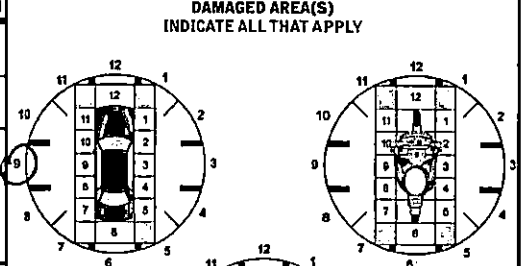

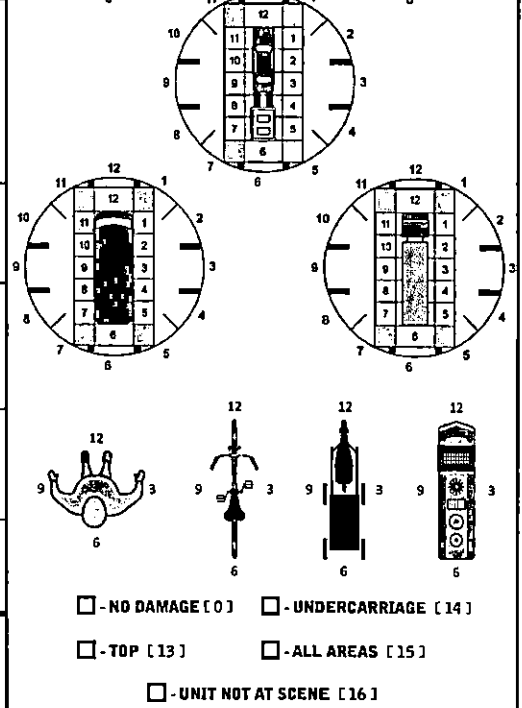

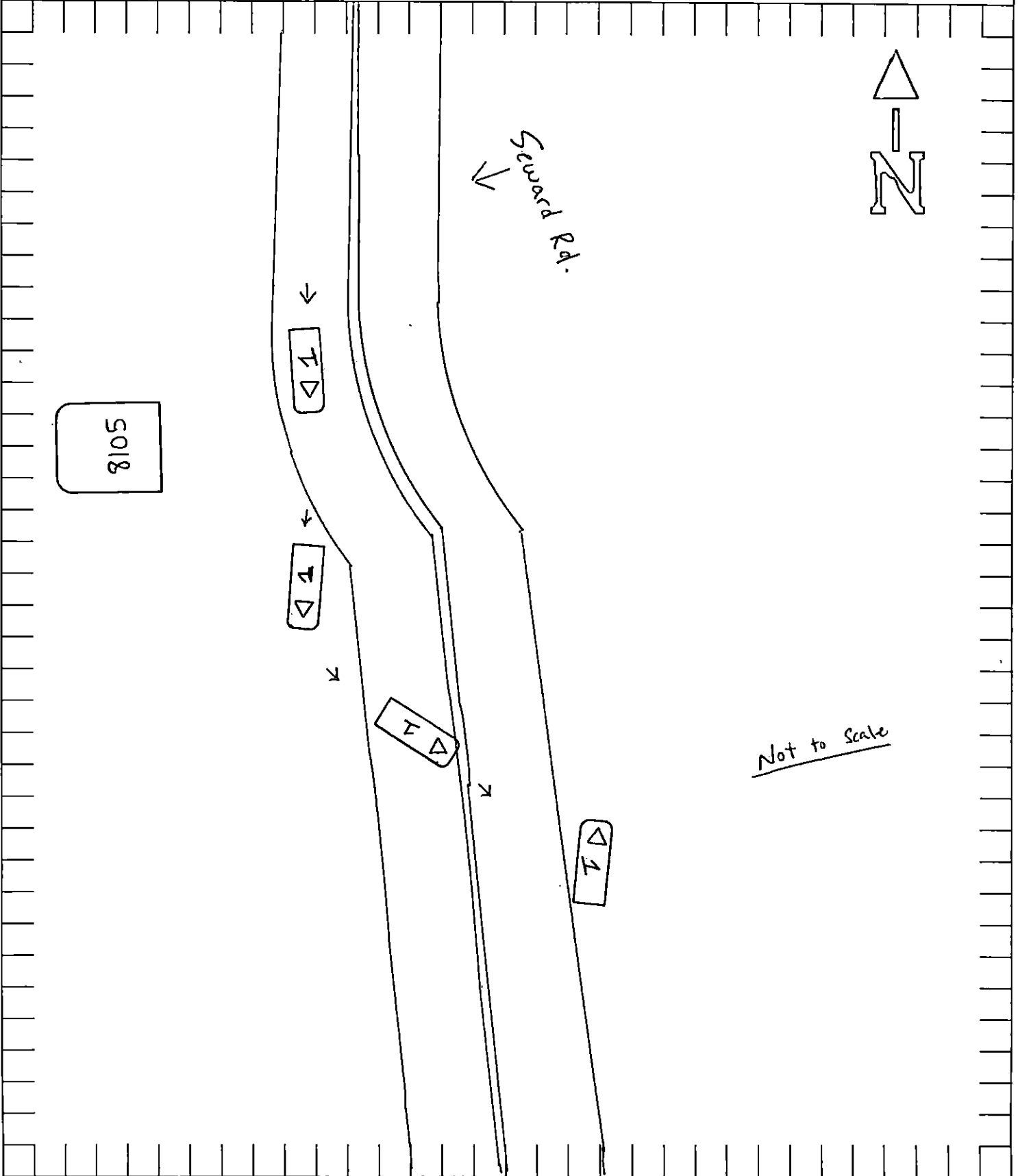
