NARRATIVE

On May 1, 2023, at 3:42 P.M., unit #2 was stopped for the posted traffic signal on Muhlhauser Road at Le Saint Drive. Unit #1 failed to maintain an assured clear distance ahead and struck unit #2 in the rear. Unit #1 driver stopped and spoke with unit #2 briefly before they fled the scene towards Dixie Highway without providing any information.

Officers checked the area but did not locate unit #1 fleeing from the crash location.
