NARRATIVE

The driver of Unit #1 stated they were traveling northbound on State Route 4 Bypass with the green light and when at the U-Turn south of Symmes Road, was struck by Unit #2 which was making the U-Turn from southbound State Route 4-Bypass to travel north.

The drive of Unit #2 stated that after stopping at the red traffic signal and after receiving a green signal they preceded to make make a U-Turn from southbound State Route 4-Bypass to travel north and was struck by Unit #1.

The crash occurred on May 1, 2023 at about 12:00 P.M. and there were no witnesses to the crash.

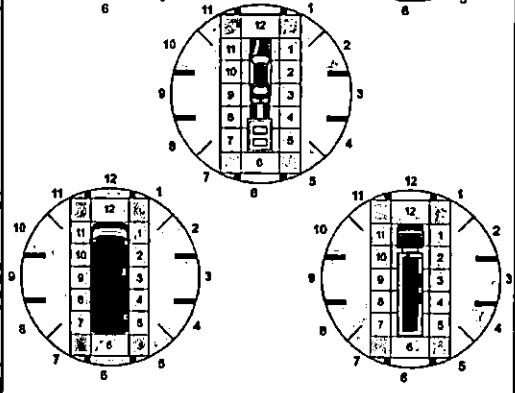

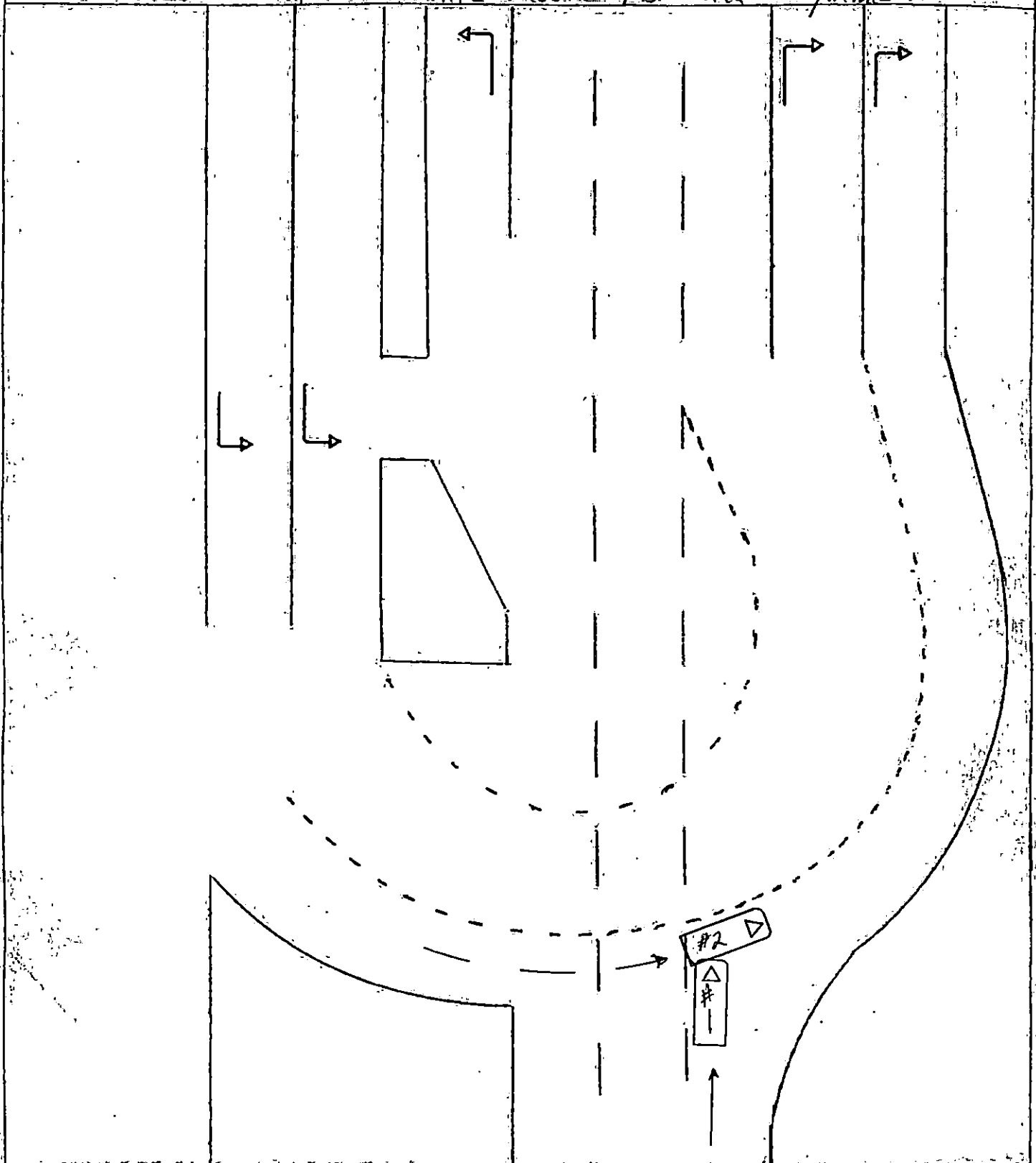
