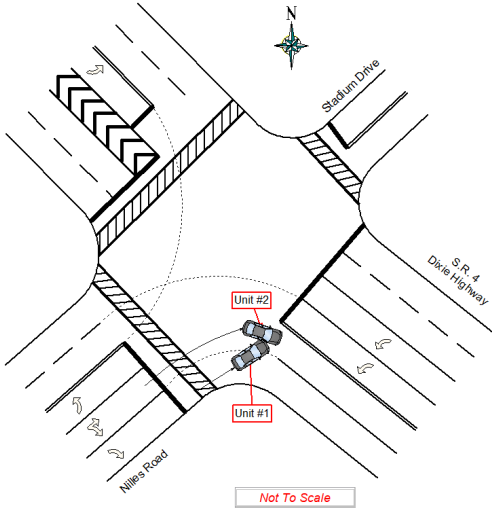

NARRATIVE On 01/23/2025 at approximately 7:46 AM the driver of unit #1 stated they were in the through lane of travel on Nilles Rd. at SR 4. She stated that unit #2 was in the right turn only lane of Nilles Rd. The driver of unit #1 stated that when the light turned green she was driving straight through the intersection when unit #2 drove straight instead of turning and collided into them. The driver of unit #2 stated that she was in the center lane of Nilles Rd. at SR 4 which can go straight or turn right. Unit #1 was in the right turn only lane on Nilles Rd. at SR 4. The driver of unit #2 stated that when she had the green signal she proceeded to turn right onto SR 4. Unit #1 went straight instead of turning and collided into unit #2. The damage on the vehicles is consistent with the events told by the driver of unit #2, however the driver of unit #1 and her passenger were adamant about her version of the crash.				DIAGRAM

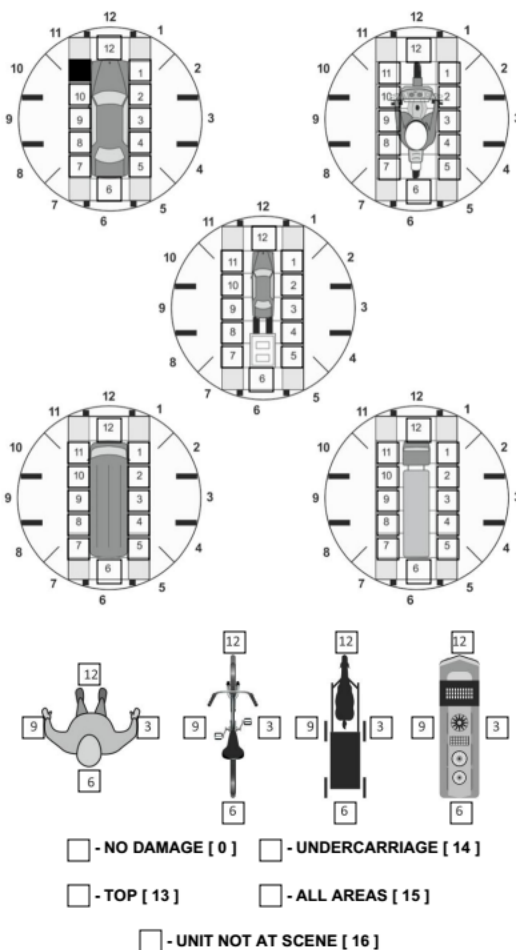

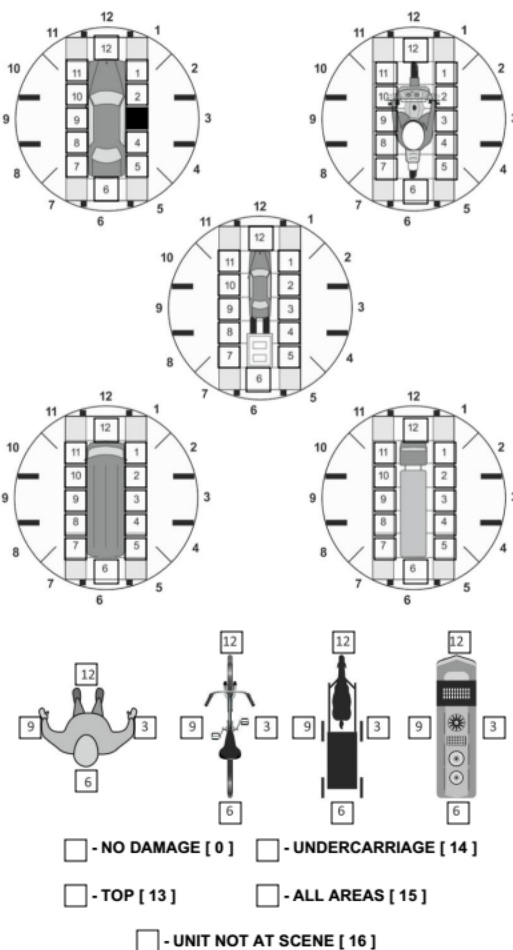
