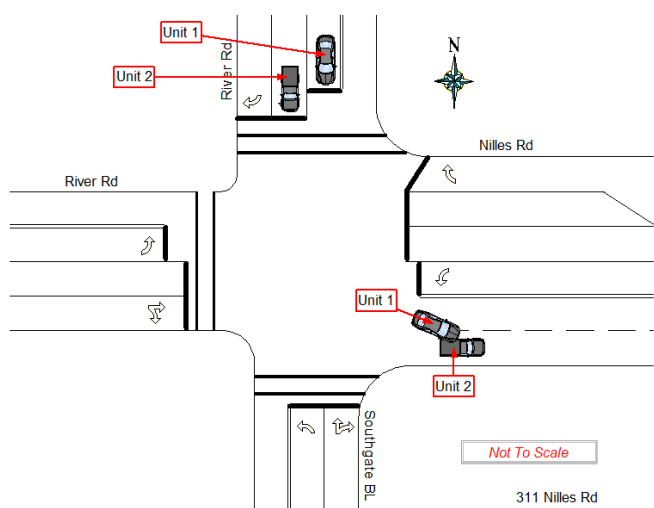

Unit 2 remained in its required lane of the turn while Unit 1 made the turn and immediately crossed the broken white line from the inside turn lane and entered the outside turn lane striking Unit 2 in the driver side. 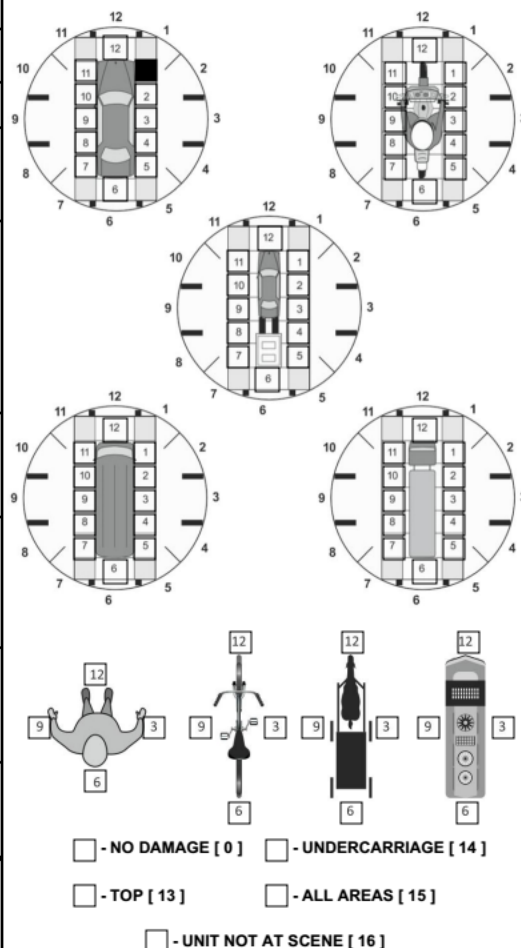

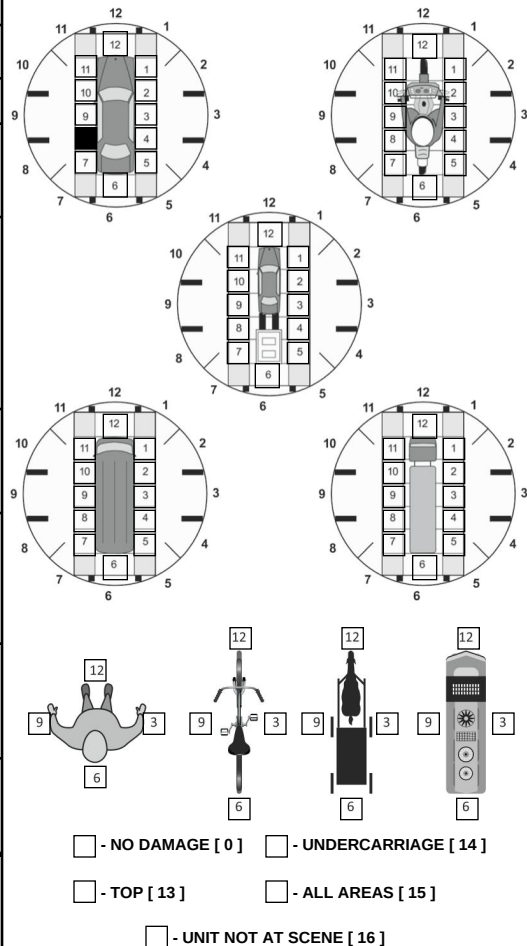
