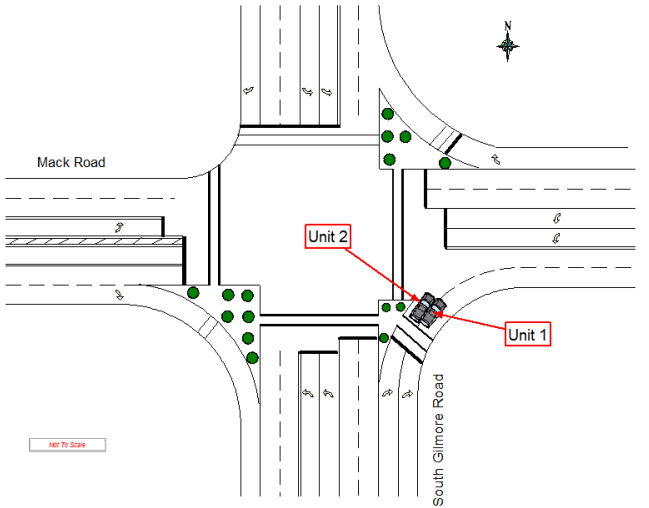

NARRATIVE On February 7, 2025, at 3:42 pm., Unit 1 and unit 2 were in the turn lanes of northbound South Gilmore Road attempting to turn right (east) onto Mack Road. Unit 1 driver said they were in the right (curb lane) when they made their turn. Unit 1 driver said unit 2 crossed into their lane of travel and struck them from behind. Unit 2 driver said they were in the left lane turning right and was struck in the right front by unit 1 when the driver of unit 1 crossed over into their lane of travel. Due to vastly conflicting stories and no witness, neither driver was cited or deemed at fault. The collision resulted in minor damage.						DIAGRAM

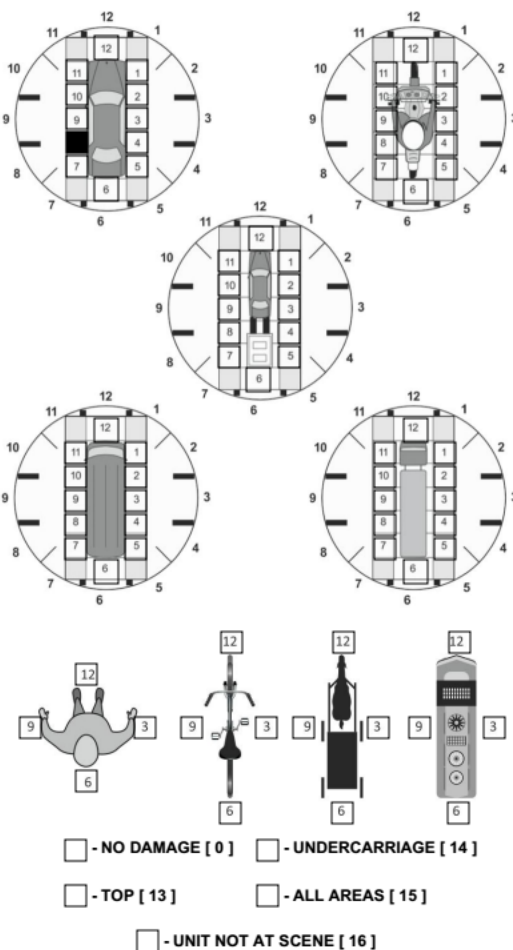

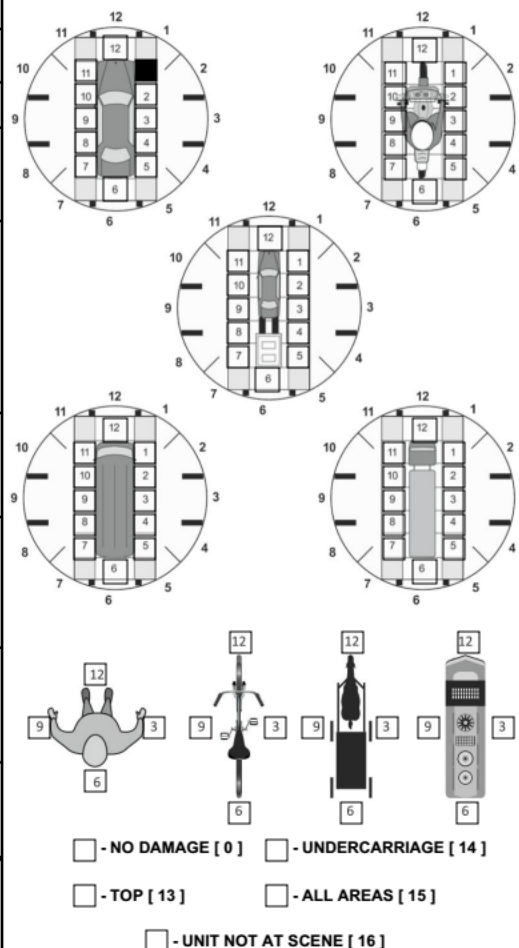
