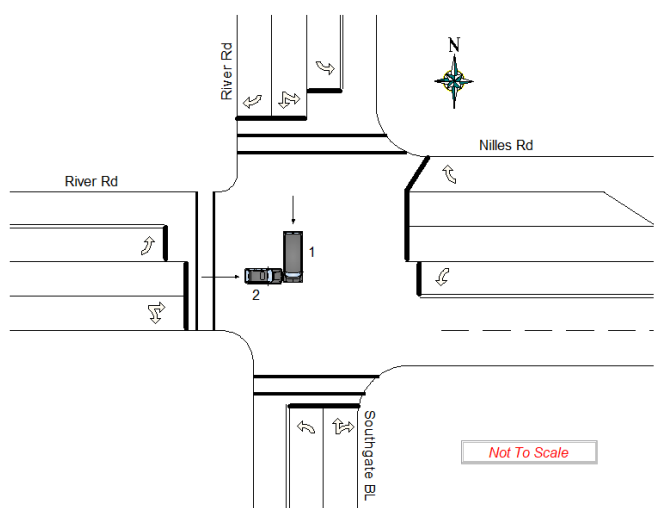

The traffic signal for south bound River Rd was red for Unit 1. Unit 1 proceeded into the intersection against the red light, and was struck on the front passenger side by Unit 2. 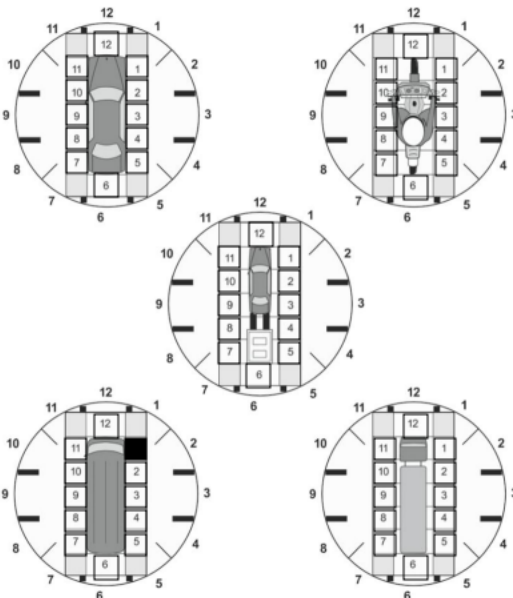

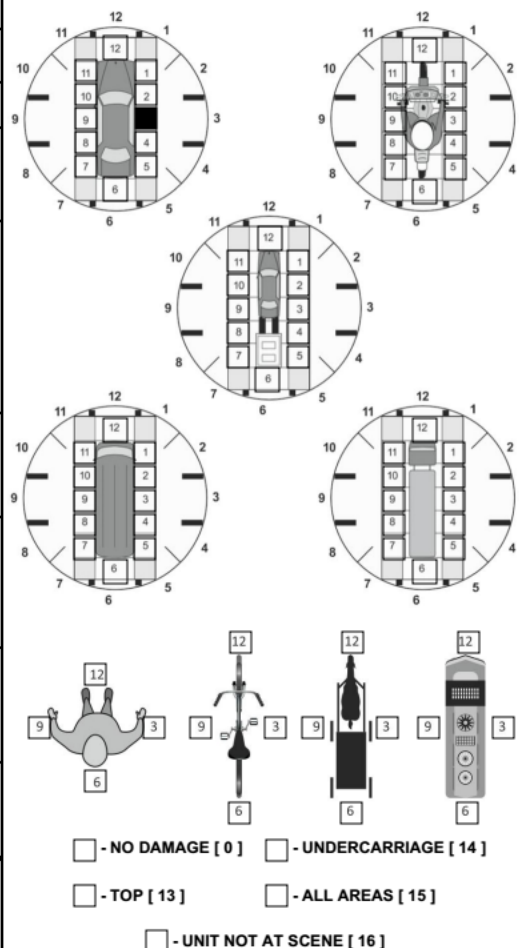
