Unit 2 claimed they had the green light and passed through the intersection at Dixie Hwy and Jungle Jim Dr. Unit 1 turned left from Jungle Jim's Drive and struck Unit 2 on the driver-side rear tier. On March 2, 2025, at 5:50 p.m., unit 1 said they had the green light to turn left from Jungle Jim's Drive onto Dixie Hwy eastbound. Unit 1 claimed unit 2 ran the light and struck their front bumper. 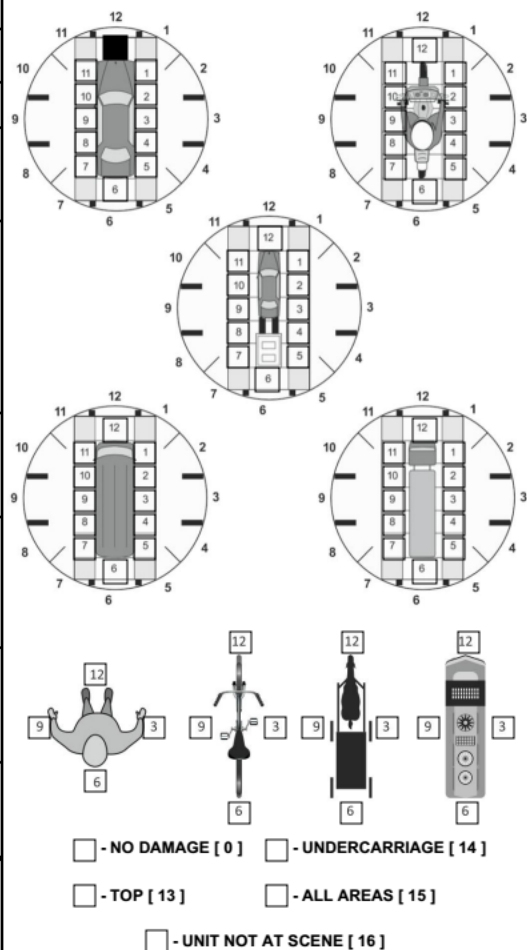

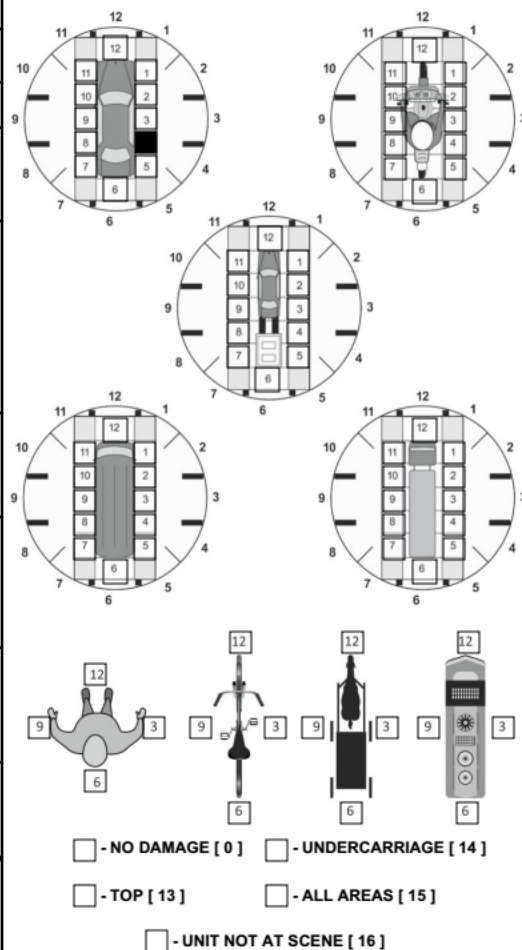
