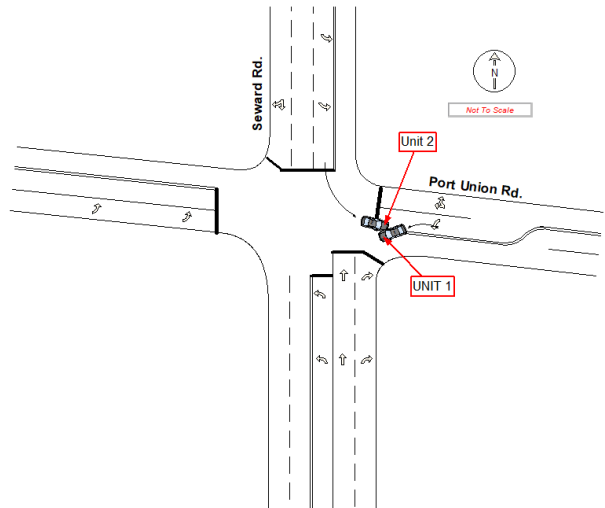

NARRATIVE

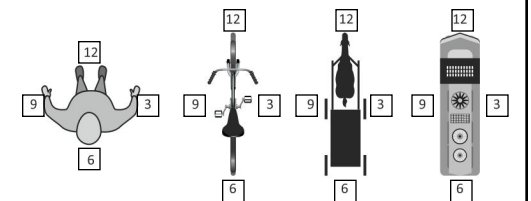
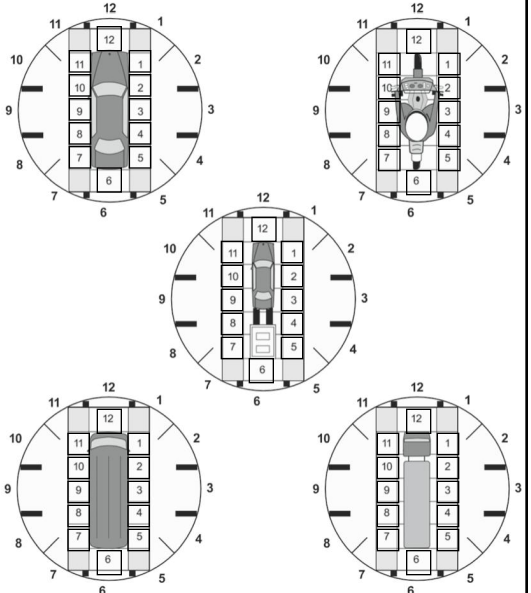

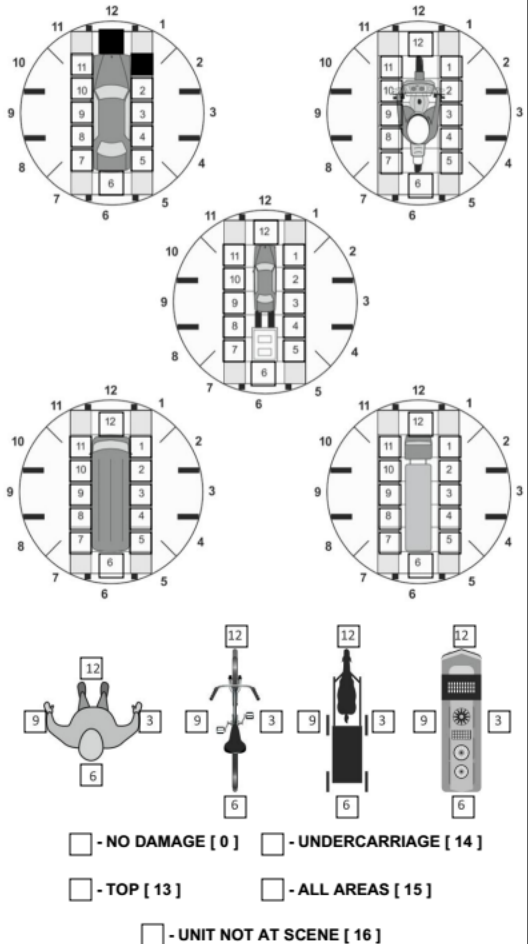
