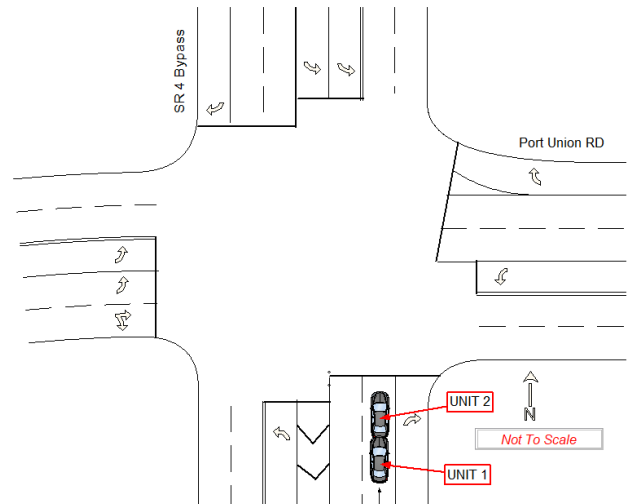

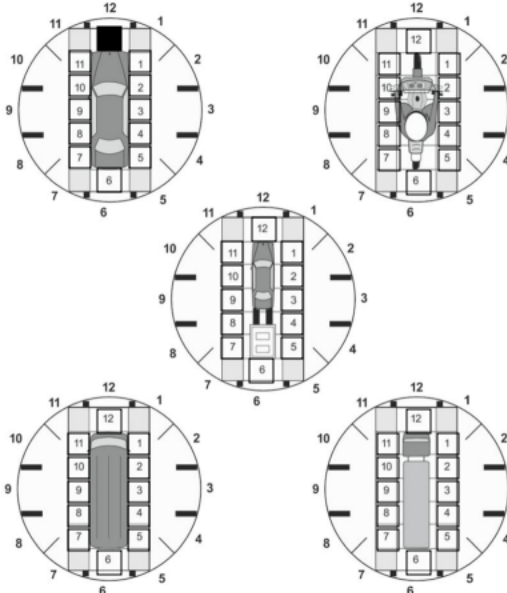
NARRATIVE

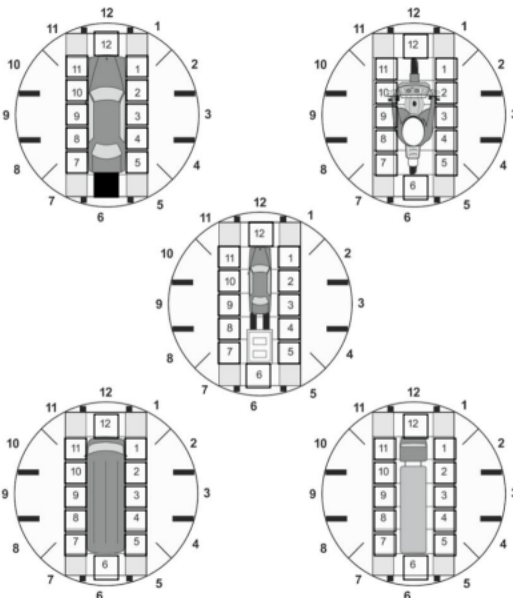
