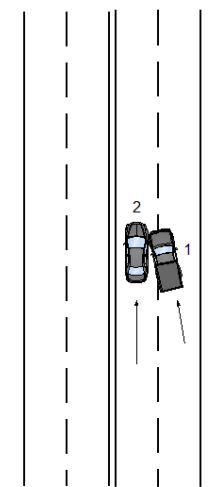

NARRATIVE On 03/20/25 at around 4:51 a.m. Units 1 and Unit 2 were traveling north on South Gilmore Rd, approximately 150 feet north of the intersection with Annandale Dr. Unit 1 was in the curb lane, Unit 2 was in the inside lane of travel. Due to the slick road conditions, Unit 1 failed to maintain control of their vehicle, and slid out of the curb lane and into the inside lane of travel, striking Unit 2. 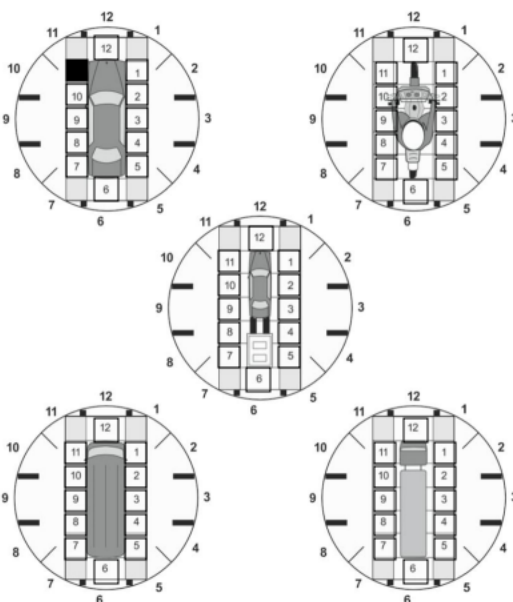

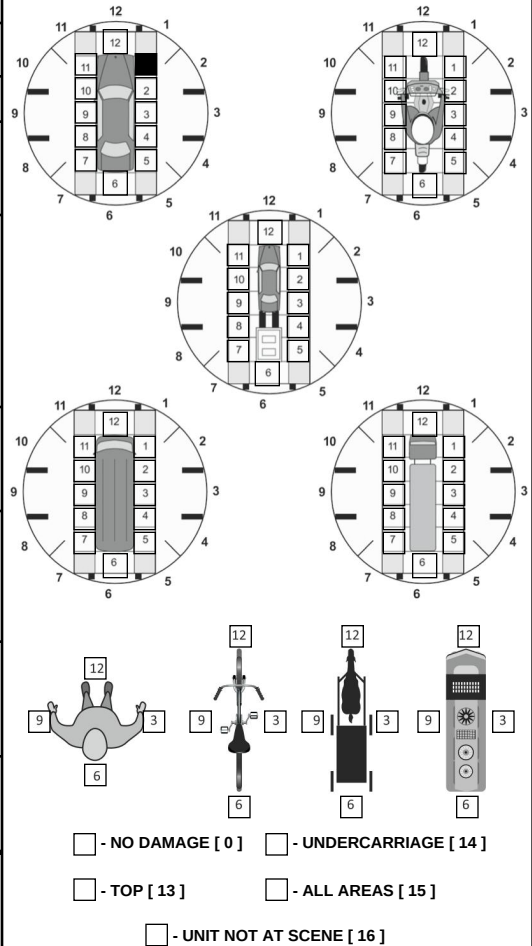
