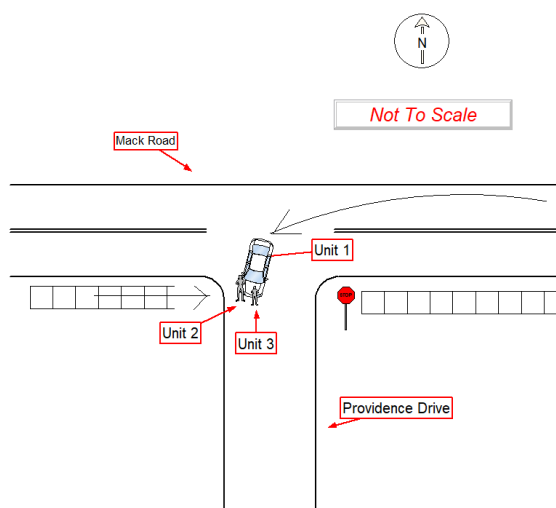

NARRATIVE On 3/29/2025 at around 8:42 P.M. Unit 1 was traveling west on Mack Road and when at Providence Drive made a left turn to begin traveling south. During Unit 1's left turn, Unit 2 and 3 were walking east on Mack Road on the sidewalk. They attempted to cross over Providence Drive in an unmarked crosswalk when they were struck by Unit 1. Unit 2 and 3 stated that they were already crossing over Providence Drive before Unit 1 began their left turn from Mack Road. 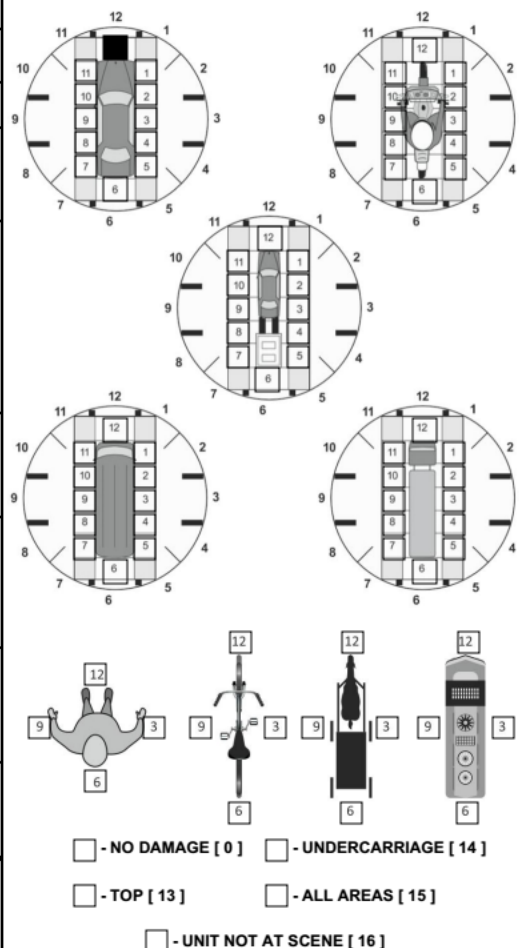

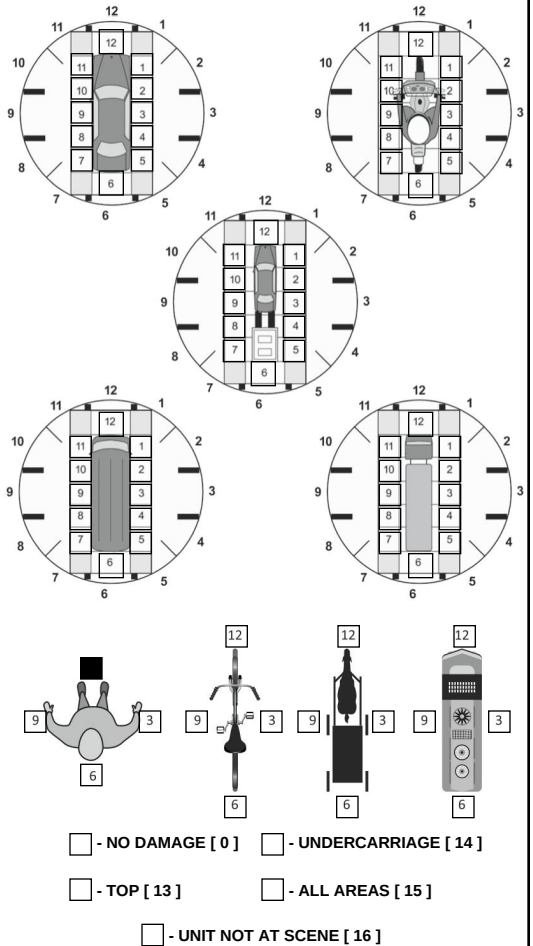
