NARRATIVE

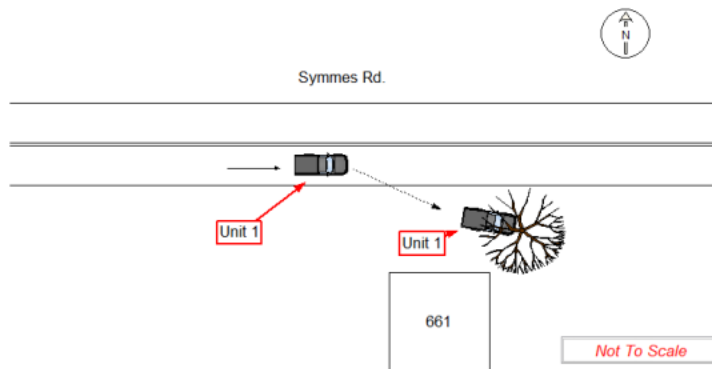
On 4/2/25 at 8:09 A.M. unit 1 was traveling east on Symmes Rd. at approximately 35 MPH. Unit 1 driver stated that the front passenger in the vehicle grabbed the steering wheel causing the vehicle to veer off the right side of the roadway and into a tree.

The passenger of unit 1 stated that the driver of unit 1 was grabbing her hair during an argument, which caused the driver to lose control and veer off the right side of the roadway and into a tree.

Due to the conflicting accounts of what occurred the driver of unit 1 was not cited for the crash.

The tree belongs to Edward Harper at 661 Symmes Rd.
