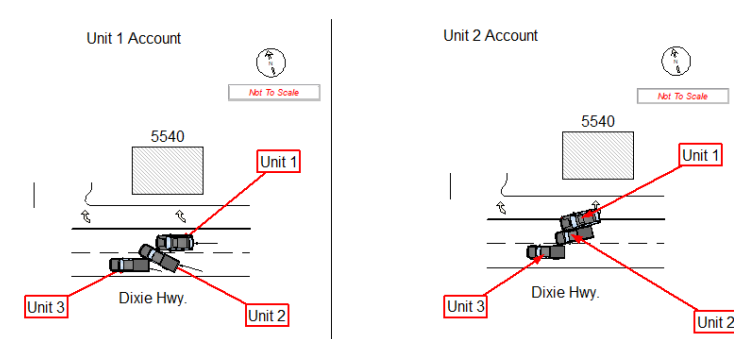

Unit 1's driver said that Unit 2 was traveling in the left most through lane directly behind Unit 3 when the driver of Unit 2 merged right into her lane side swiping Unit 1 and Unit 3. The driver of Unit 2 said that Unit 2 was traveling in the right most through lane when Unit 1 merged into his lane striking Unit 2 and caused Unit 2 to then sideswipe Unit 3. 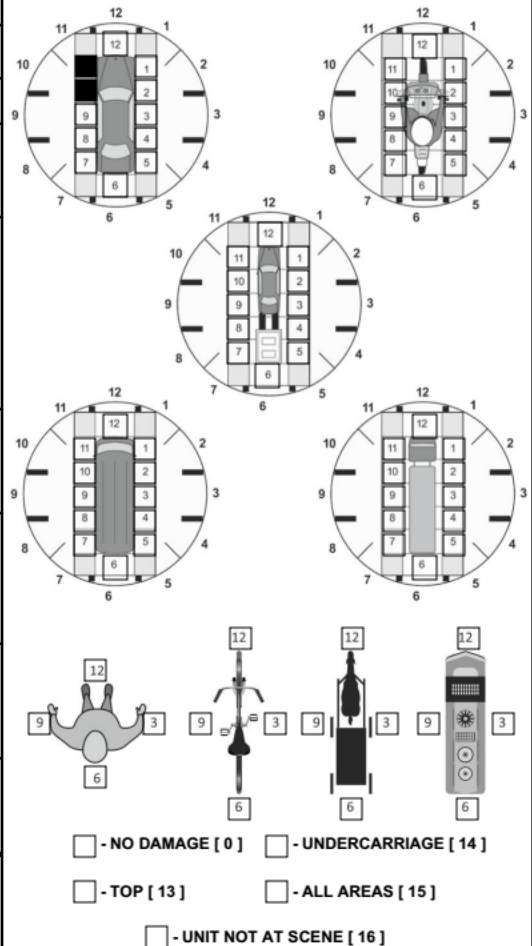

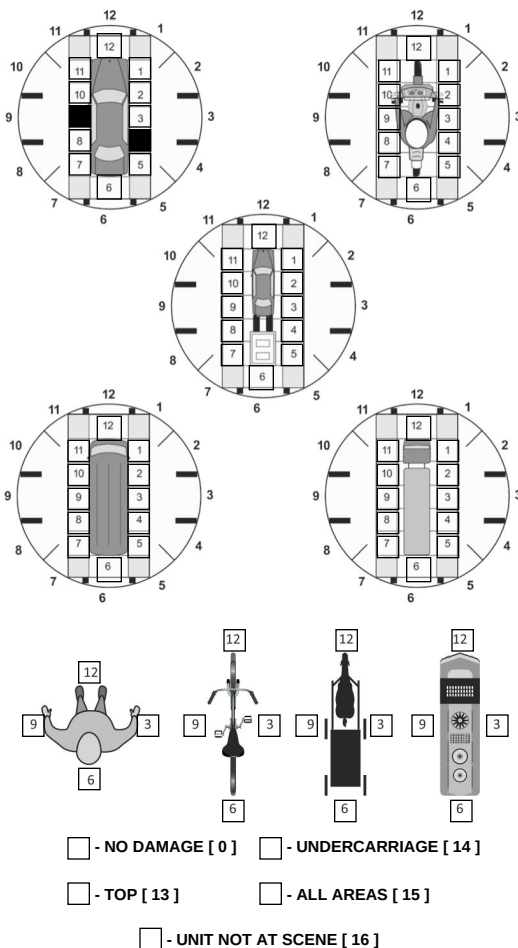

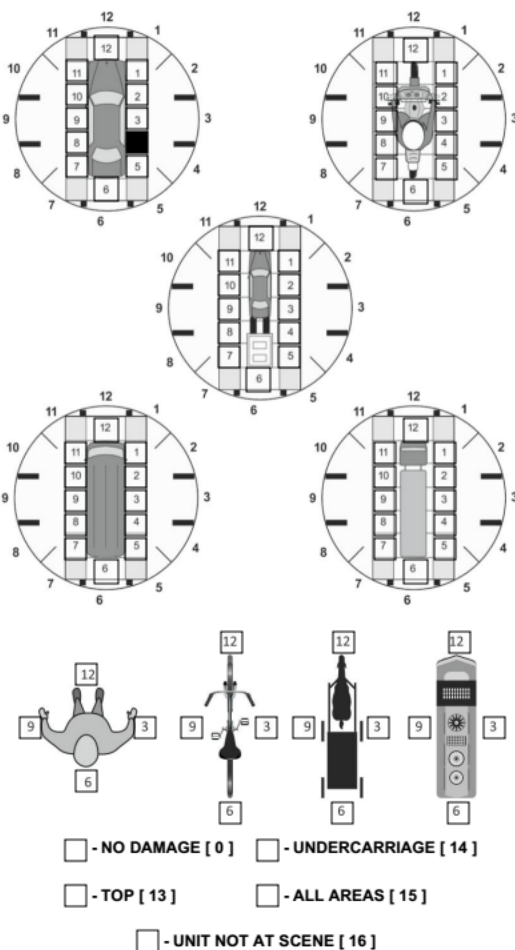
