NARRATIVE On 05/01/25 officers responded to a traffic crash around 11:28 AM. Unit 2 was traveling southbound on Dixie Hwy and unit 1 was in the northbound lane attempting to make a left turn onto Schirmer Dr. Unit 1 failed to yield making a left turn, pulling out in front of unit 2 causing a collision between the two units. This caused unit 2 to redirect to their right where momentum drove them into the front of unit 3. Unit 3 was stopped at a stop sign on Schirmer attempting to turn right onto Dixie Hwy. 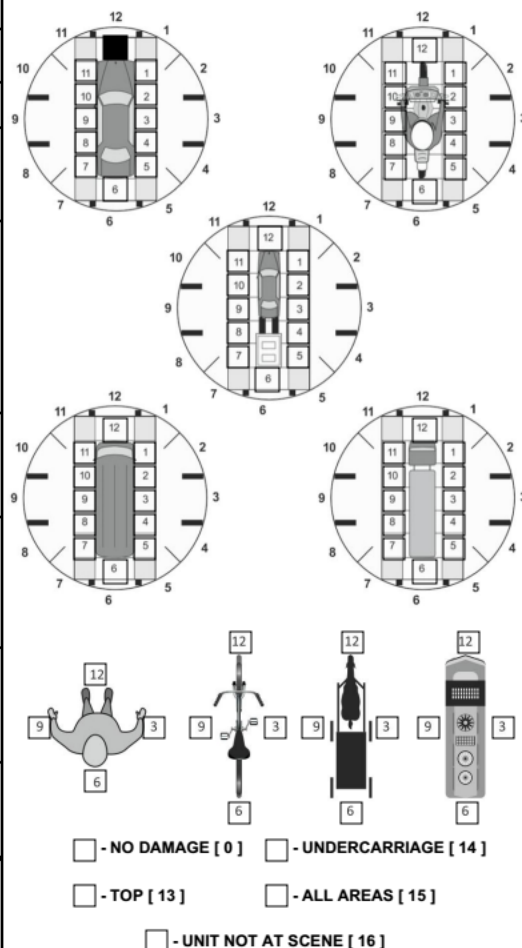
