Unit 1 is traveling Southeast on SR-4 in the right most lane to make a right hand turn on South Gilmore Rd. Unit 2 had a green arrow to make the turn and the driver of Unit 1 entered the intersection to make the turn, failing to yield to Unit 2. The driver of Unit 2 swerved to avoid a collision with Unit 1 while making the turn and lost control of the motorcycle. The driver of Unit 2 was thrown from the motorcycle and the motorcycle fell to the ground. There was not a collision between Unit 1 and Unit 2.

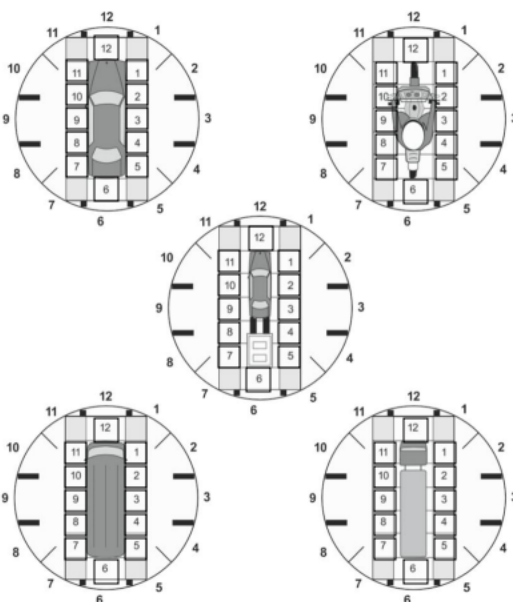
