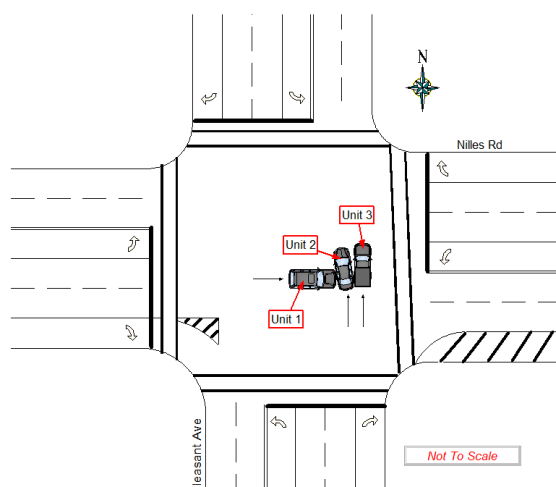

This caused unit 2 to push its rear end into the left rear of unit 3.

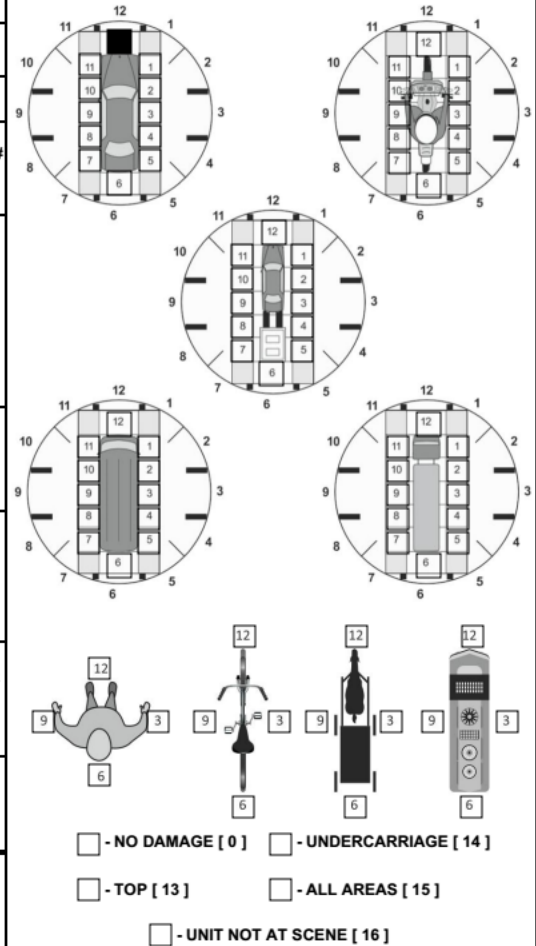

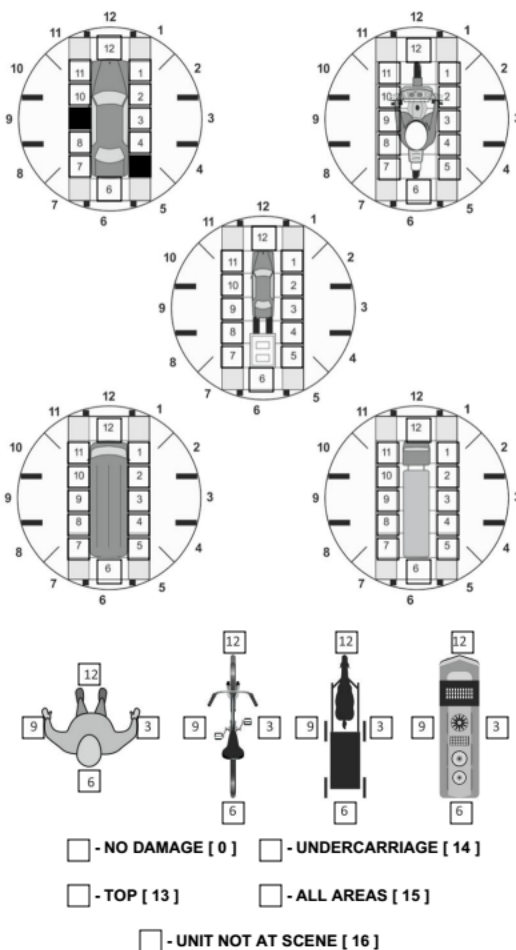

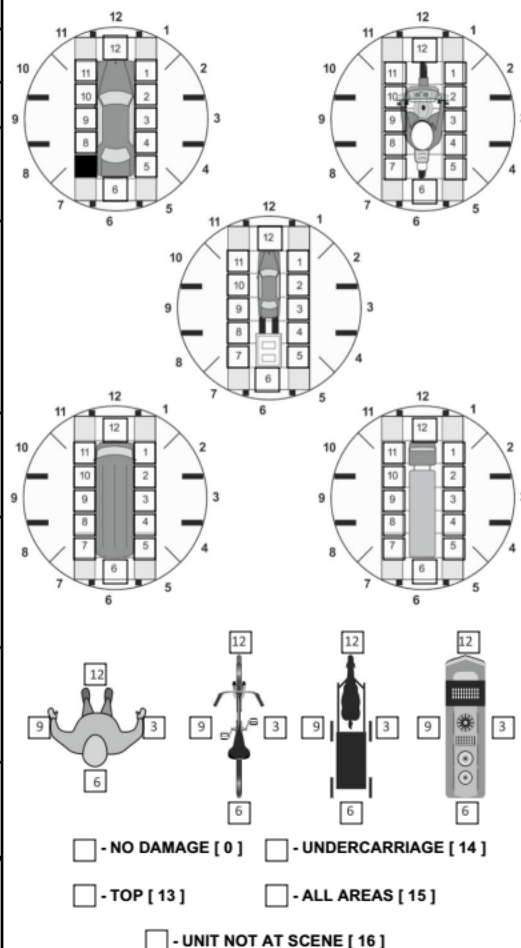
