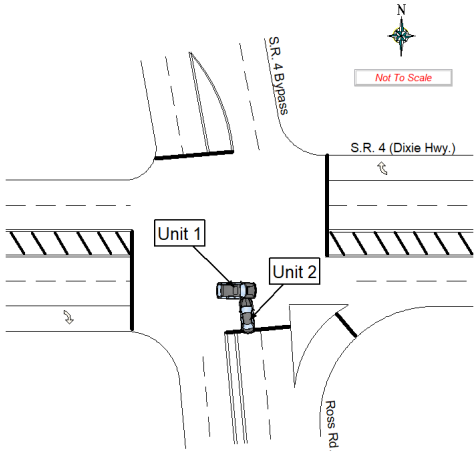

Unit 1 and Unit 2 entered the intersection of SR4 (Dixie Hwy) / Ross Rd and struck each other (Passenger side of Unit 1 and Front of Unit 2). 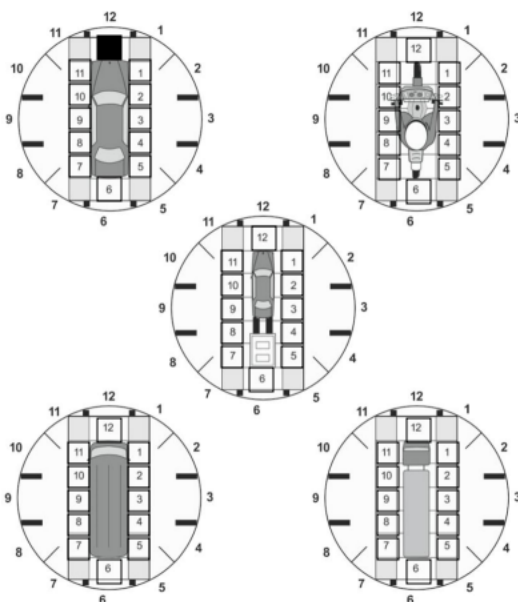
