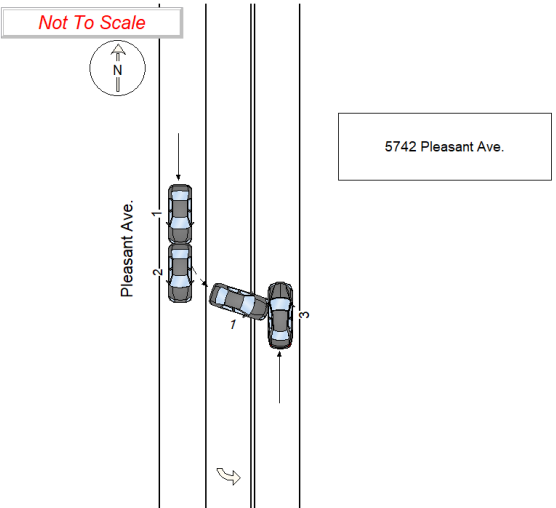

NARRATIVE On 04/13/25 at around 10:24 p.m., Unit 2 was traveling south on Pleasant Ave. in the right through lane at approximately 35 m.p.h. At the same time, Unit 1 was traveling south on Pleasant Ave. in the right through lane at a speed greater than 35 m.p.h. and when near 5742 Pleasant Ave., failed to stop within the assured clear distance ahead, colliding with the rear of Unit 2. Unit 1 then crossed the centerline and traveled into the opposing lane of travel, colliding with Unit 3. Unit 2 and Unit 3 then ran off of the roadway right. The driver of Unit 1 was also cited with OVI (FCO 333.01a1A) - M1 and OVI (FCO 333.01a1D) - M1. The driver of Unit 3 was cited with Expired O/L (FCO 335.01a1) - MM.						DIAGRAM

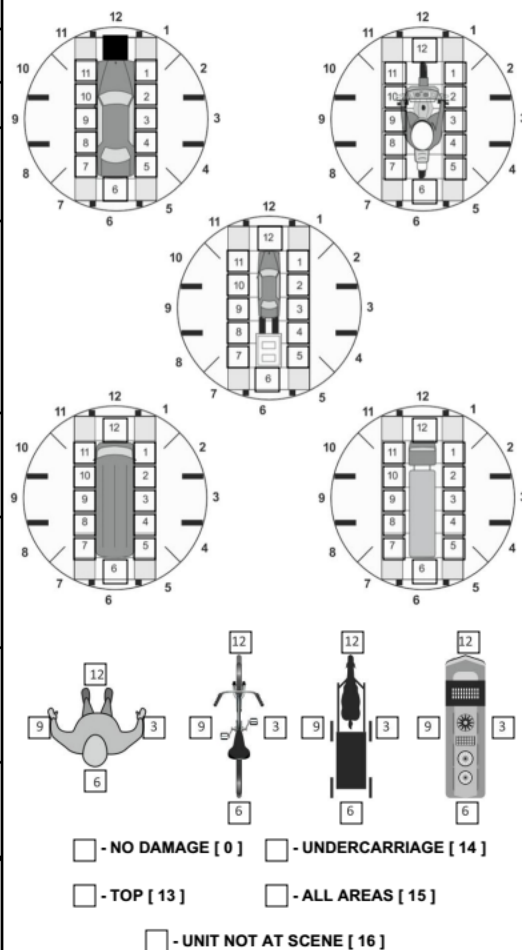

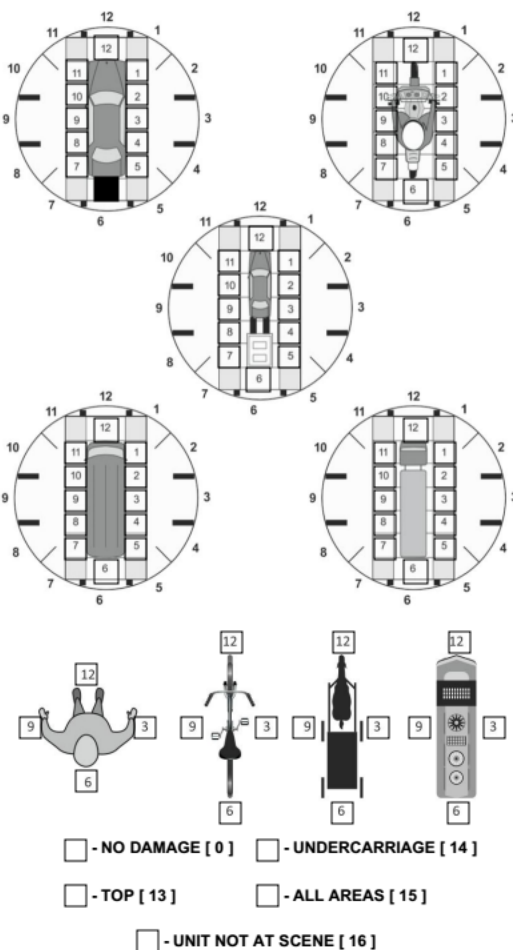

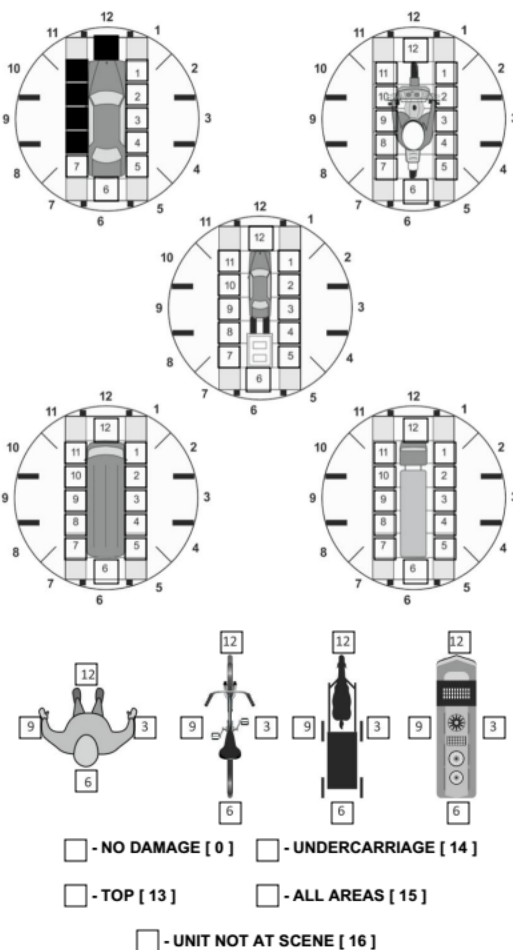
