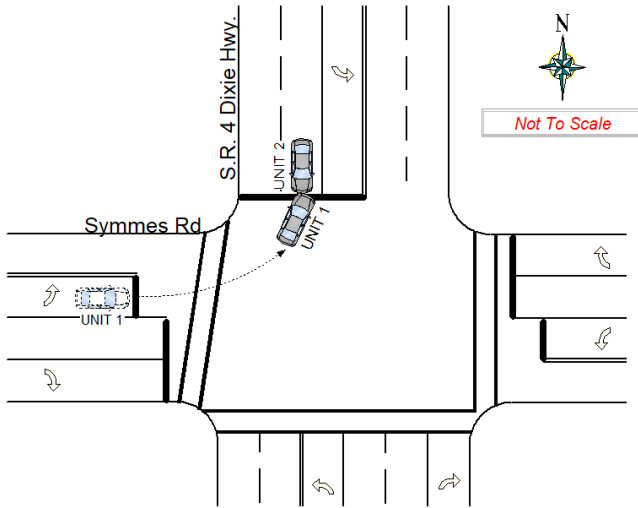

NARRATIVE On July 10, 2025 at about 1:38 a.m. Unit 2 was sitting on Dixie Hwy facing southbound in the inside lane at the intersection of Symmes Road. Unit 2 was behind the stop line sitting at a red traffic light. Unit 1 was traveling eastbound on Symmes Road. Unit 1 turned left onto northbound Dixie Highway. Unit 1 made the left turn too short and struck the front of Unit 2. Unit 1 continued northbound and pulled over. The driver of Unit 1 approached the driver of Unit 2, but then quickly retreated back to the car and left the scene without exchanging information, or contacting the Fairfield Police Department to report the accident. 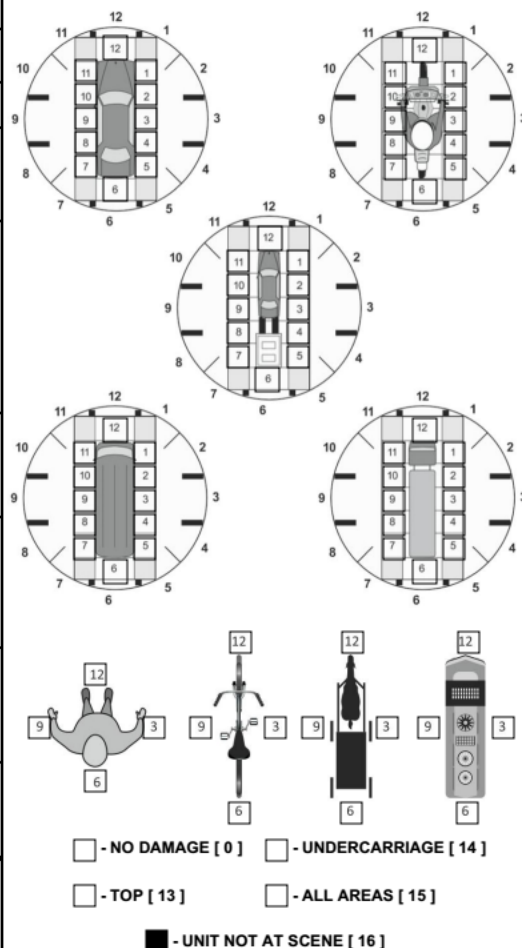

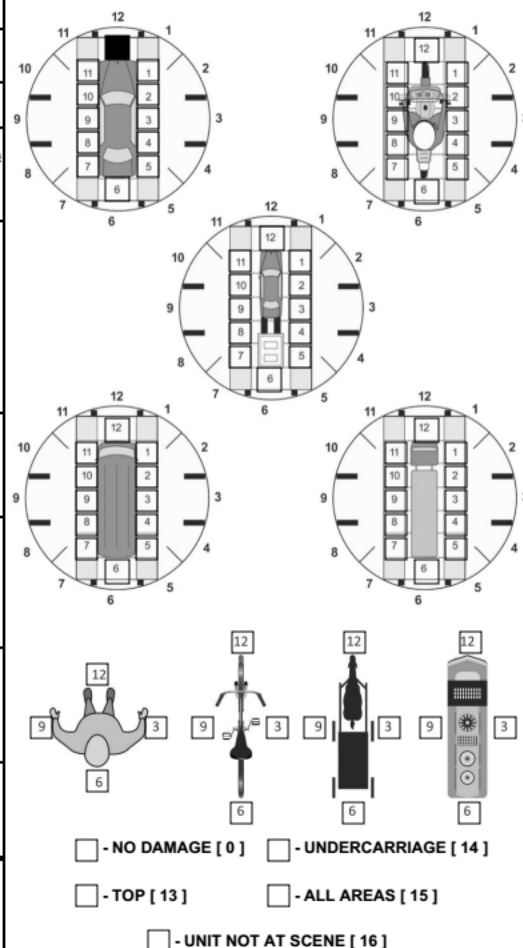
