Units 1 and 2 were driving side by side. The driver of Unit 1 failed to maintain their lane and entered Unit 2's lane of travel. Unit 1 struck Unit 2 on the driver side middle. Unit 2 is a tow truck that was towing 2 vehicles. One vehicle was on the flatbed of the tow truck, that had a license plate of JLL4729 (Toyota Supra). The other vehicle was being towed behind the truck. The license plate of the vehicle being towed was KY-JODOG (Mercedes-Benz AMG SL 65). There was not any damage to either vehicle being towed. 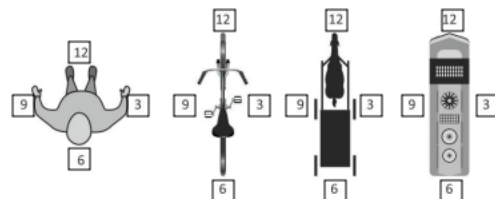
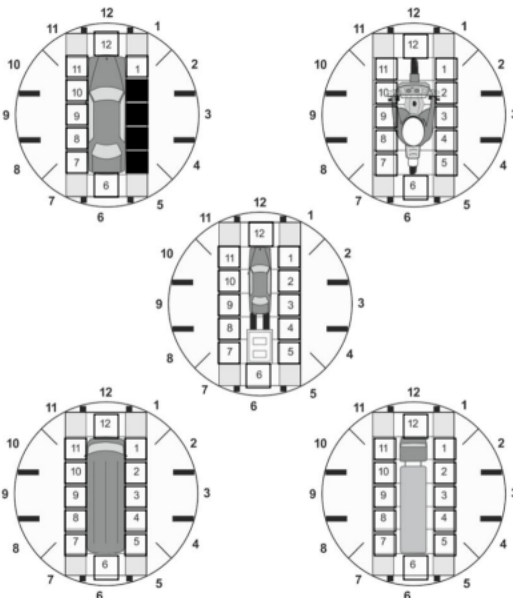

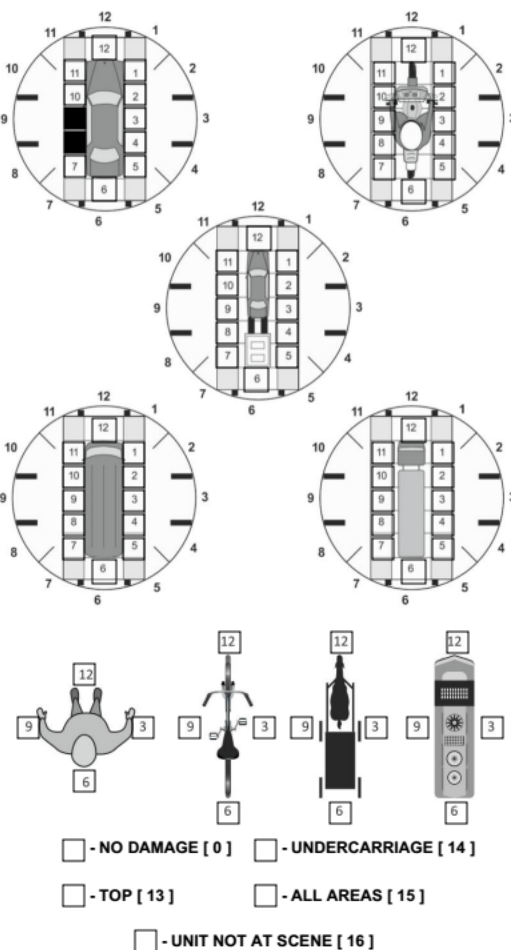
