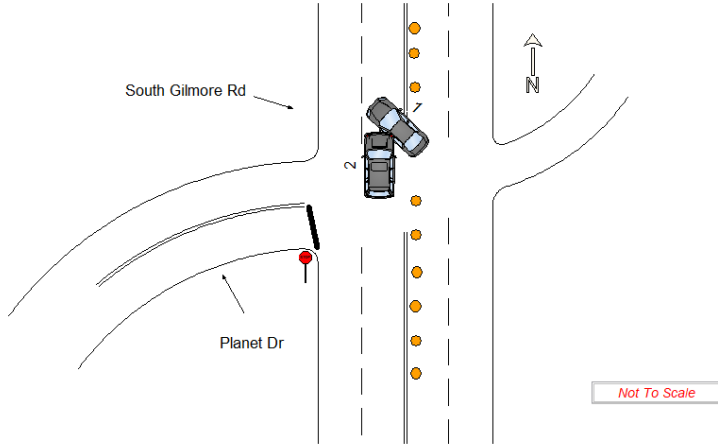

NARRATIVE On 08/02/25 at around 10:41 p.m., Unit 1 was traveling east on Planet Dr. approaching S. Gilmore Rd. Unit 1 then turned left onto S. Gilmore Rd. in order to travel northbound. The driver of Unit 1 stated that he took a wide turn when turning. The driver of Unit 1 stated Unit 2 was behind him on Planet Dr. and turned to head north on S. Gilmore Rd. In doing so, Unit 2 collided with Unit 1 in the northbound through lane. A witness stated Unit 1 was behind the barrels in the construction zone on S. Gilmore Rd. facing north. The witness stated Unit 1 then changed lanes and entered the northbound through lane and in doing so, collided with Unit 2, which was traveling north on S. Gilmore Rd. Unit 2 left the scene of the accident and was unable to be located. Due to conflicting statements and the inability to locate Unit 2, no one will be cited for the traffic crash at this time. 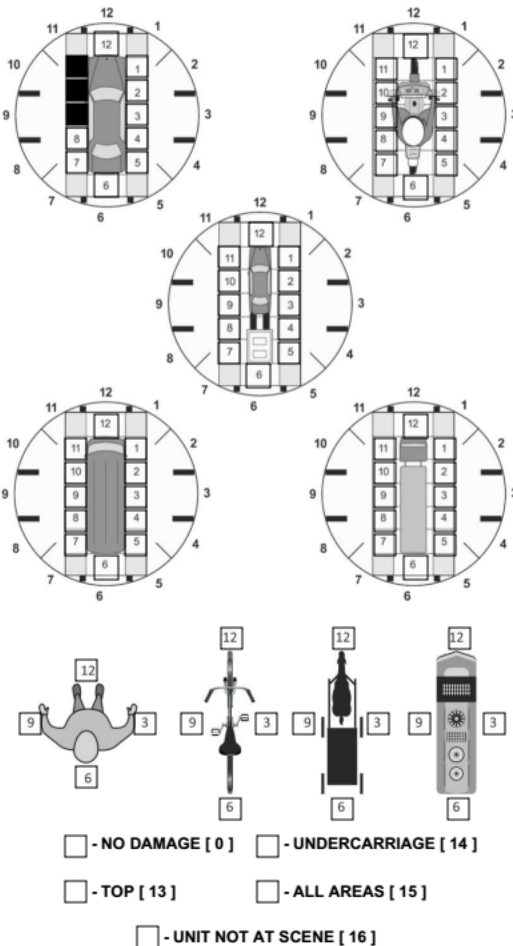

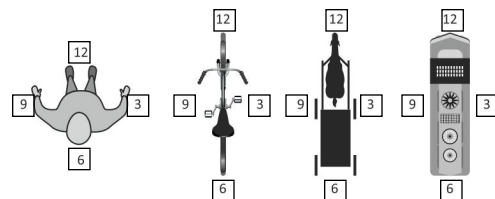
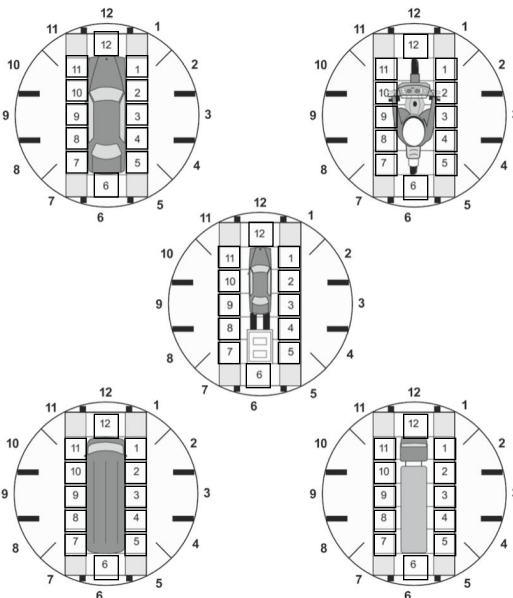
