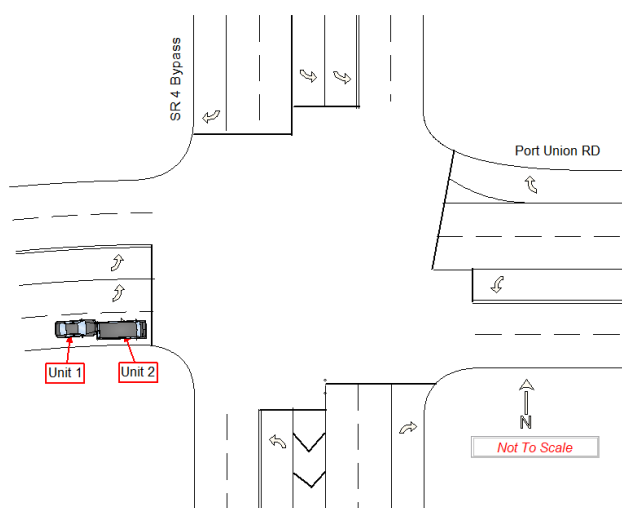

Unit 1 stated they heard someone around them beep their horn, which caused Unit 1 to drive forward, rear-ending Unit 2. 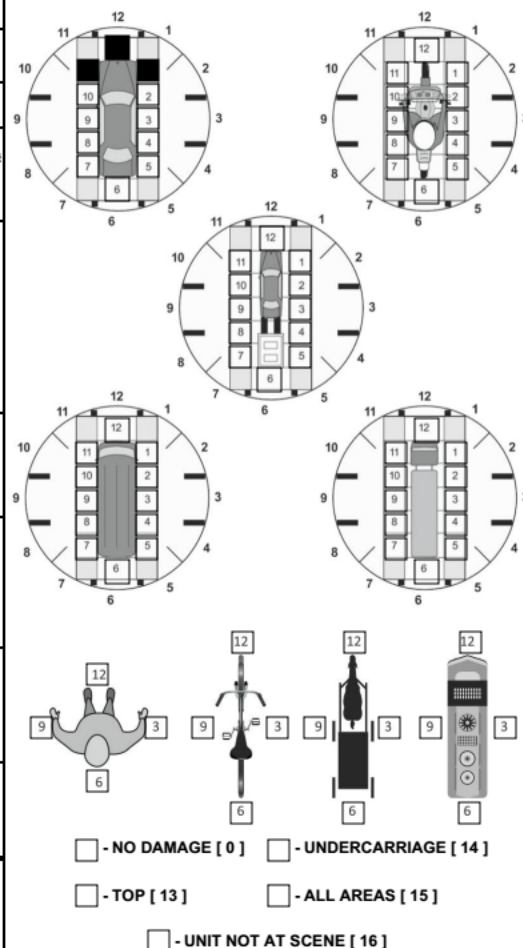

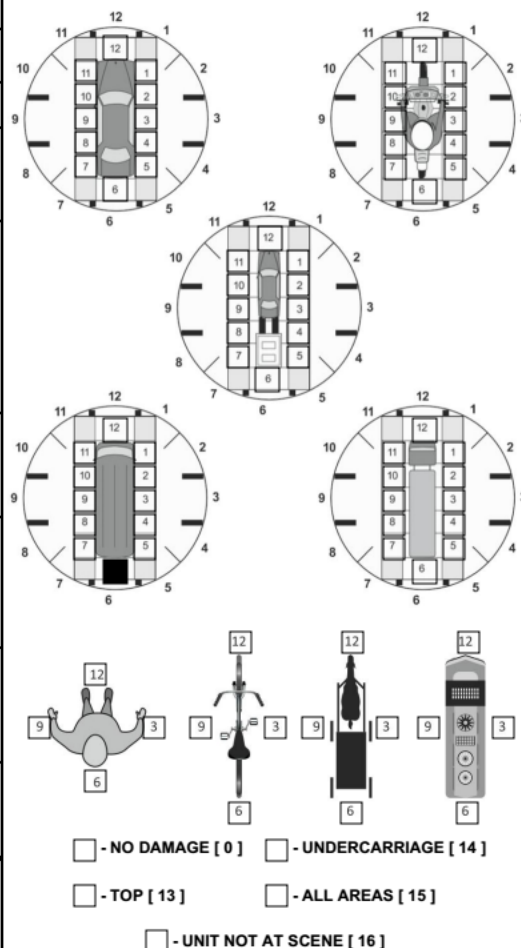
