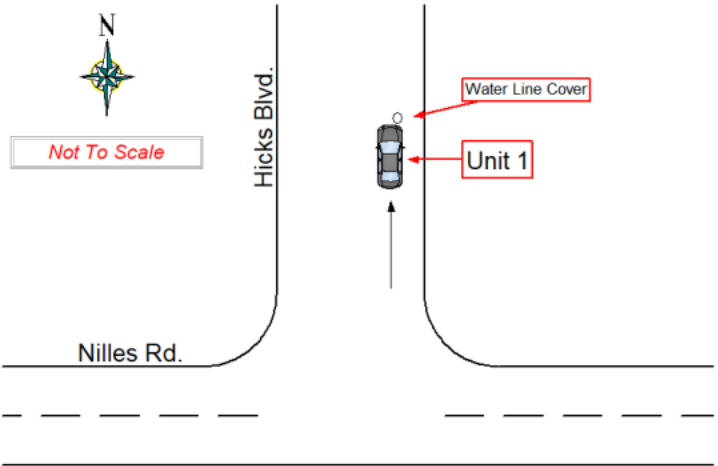

NARRATIVE On August 6, 2025 at approximately 6:20 p.m. Unit 1 was turning onto Hicks Blvd. from Nilles and when approximately 40 ft. north on Hicks Blvd. drove over an exposed water line pipe in the roadway, which caused the cap to break off and strike his oil pan, causing the oil to drain from the vehicle. The roadway was recently grinded for repavement. There was a posted caution sign near the intersection which read "Caution raised manholes," and the raised portions of the roadway were painted with fluorescent pink reflective paint to be more visible. 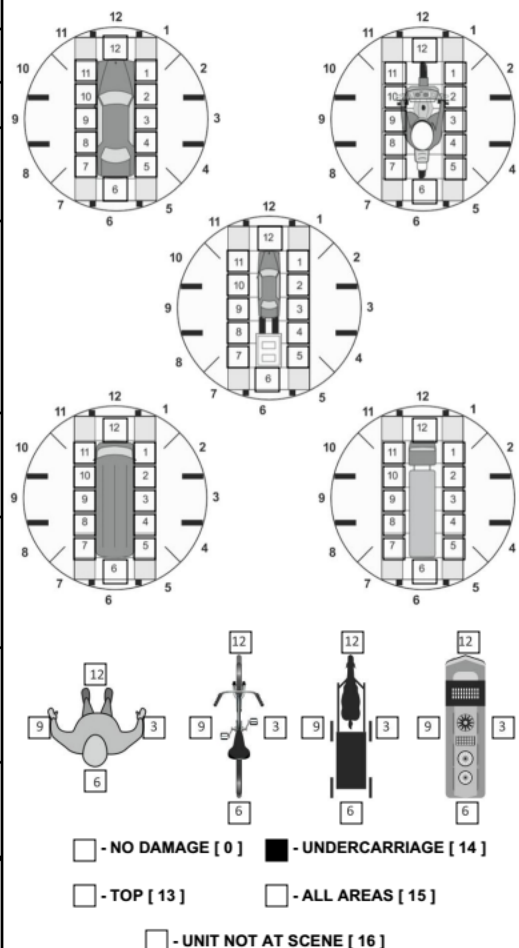
