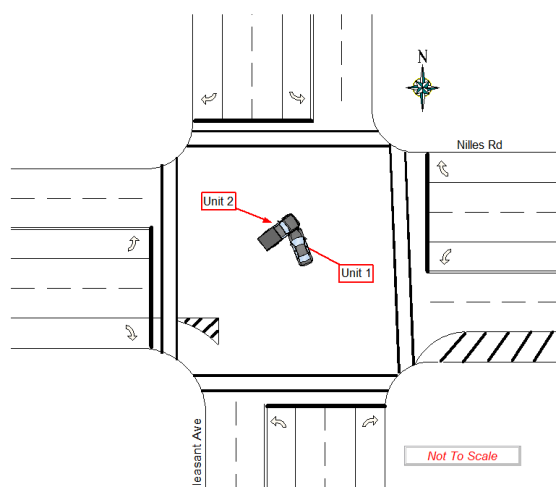

NARRATIVE On 08/08/2025 at approximately 10:27 P.M. unit 1 was northbound on Pleasant Ave. in the left through lane. Unit 2 was eastbound on Nilles Rd. attempting to turn left from the left turn lane and go north on Pleasant Ave. As unit 2 was making the left turn from Nilles Rd. to Pleasant Ave., unit 1 ran the red light and struck unit 2 in the right side. Witness stated that they observed unit 2 have the right of way, by having the green left turn arrow. The witness also stated that unit 1 had a red light and did not even slow down when it struck unit 2. Unit 1 admitted on the police in car recording that she was on her cell phone and did not even see the light. 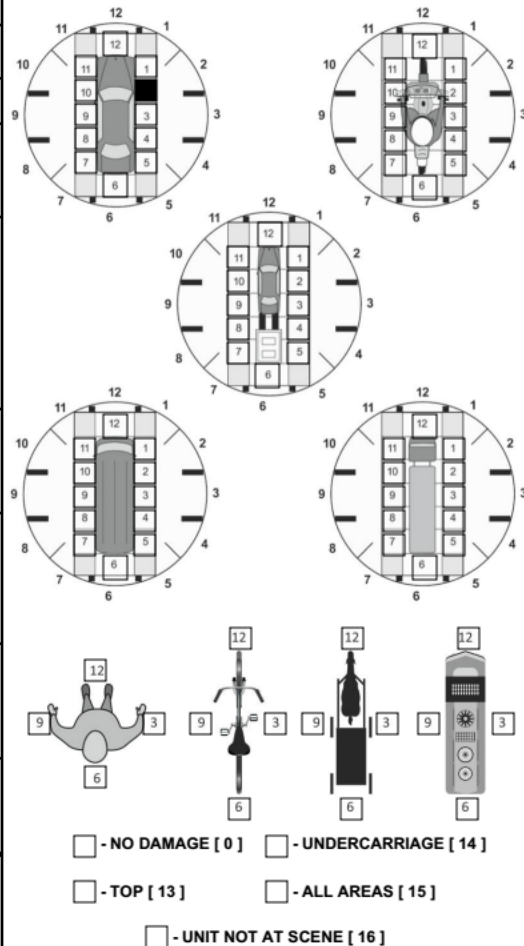

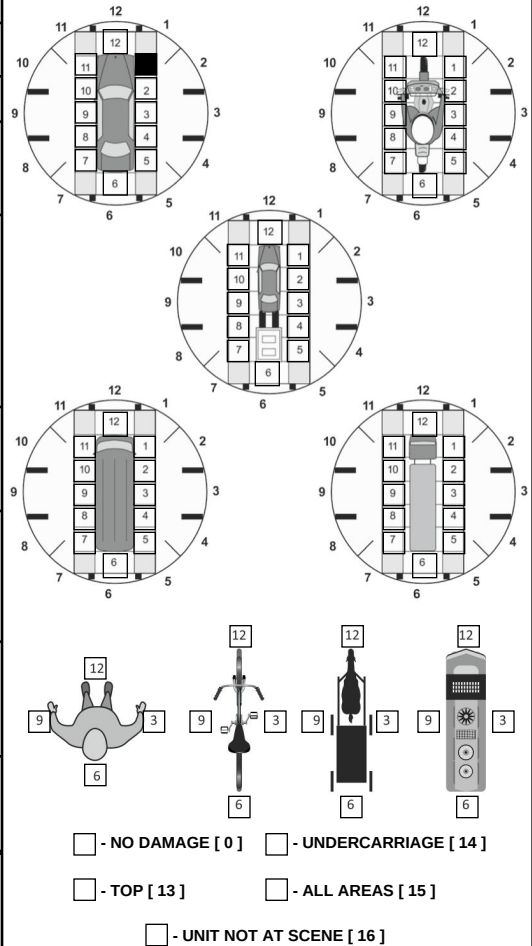
