Unit 2 was traveling northbound on Camelot Drive, slowing to turn right into the driveway of 5500 Camelot Drive. Unit 1 crossed left of center and struck the driver-side front of Unit 2. Unit 1 left the scene without stopping to exchange information, or to contact the Fairfield Police to report the accident. A black fender was located several feet away that appeared to belong to Unit 1. The part # 62025-7S220 is a left front fender belonging to a 2004-2005 Nissan Armada, Titan, or Pathfinder. 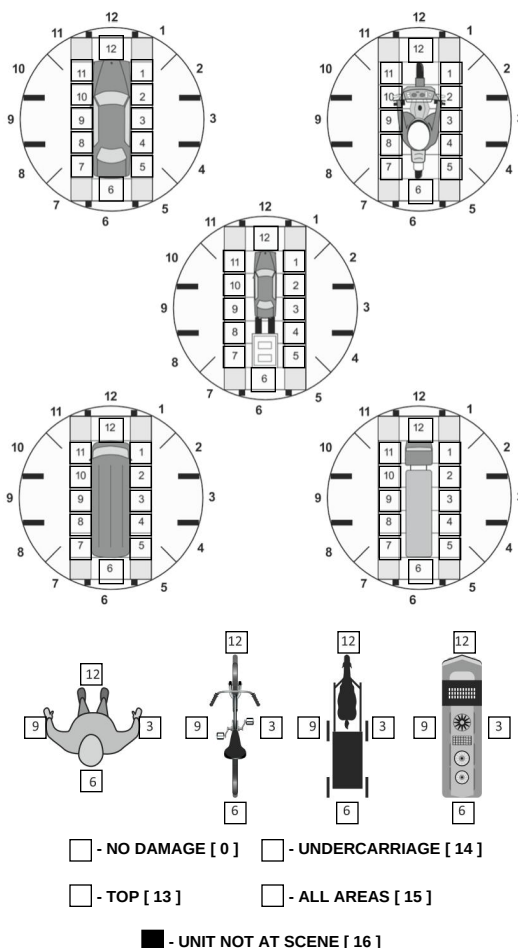

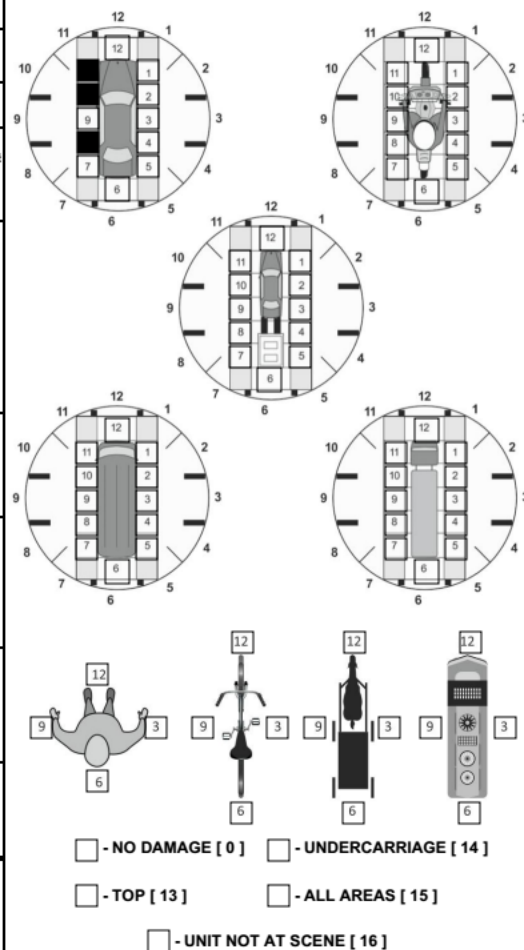
