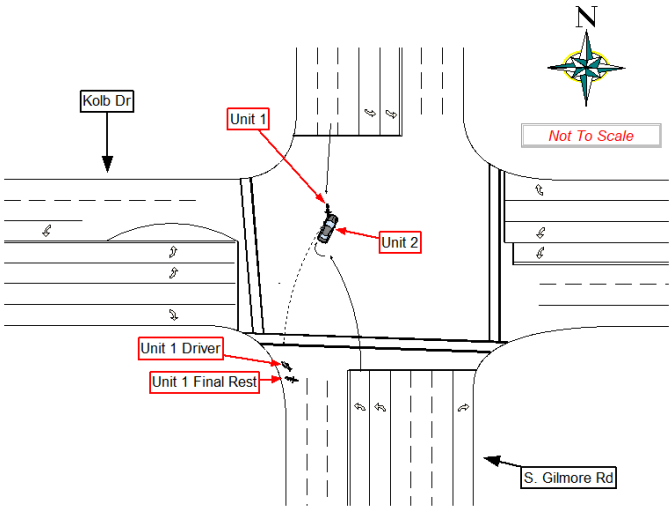

Unit 1 is a motorcycle and was traveling South on South Gilmore Rd. in the middle through lane, approaching Kolb Dr. Unit 2 was traveling North on South Gilmore Rd. in the left most turn lane to travel West on Kolb Dr. Unit 2 had a green directional arrow and started to initiate a left hand turn. When doing so, the driver of Unit 1 ran a red light and struck Unit 2 on the front driver's side. The driver of Unit 2 attempted to swerve to avoid the collision right before impact. 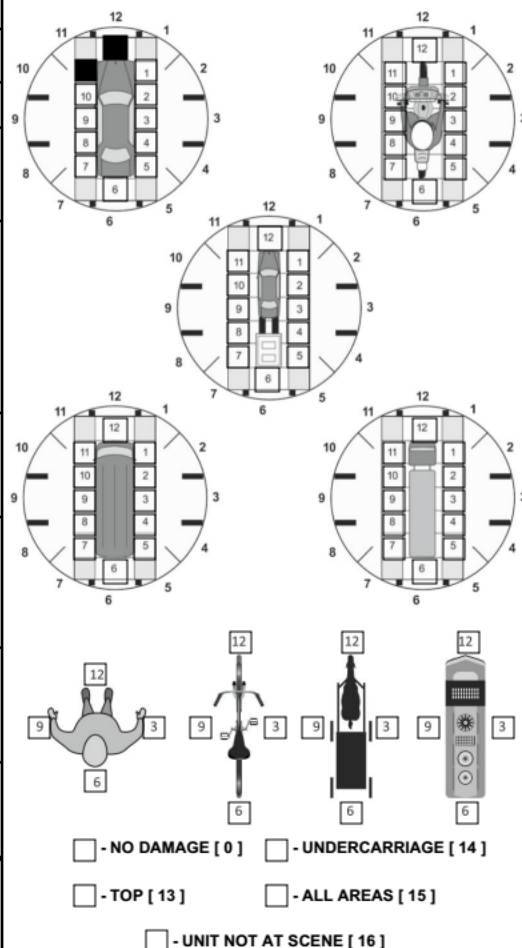
