NARRATIVE On 10/1/25 Unit 1 was traveling west on Mack Rd. and making the south bound turn onto S. Gilmore Rd. Unit 2 unexpectedly slammed their brakes causing Unit 1 to swerve to miss them but struck the rear of Unit 2. Driver of Unit 2 stated that they stopped abruptly to avoid collision with another vehicle turning in the inside lane.
