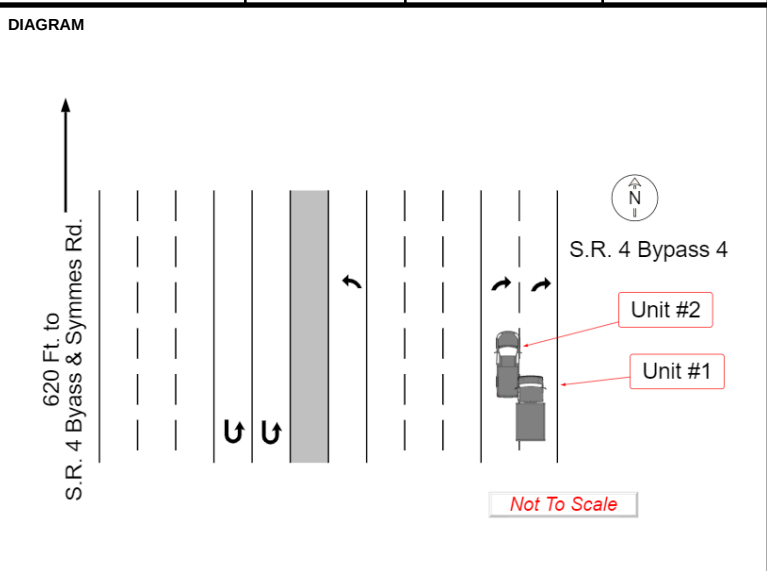

NARRATIVE On October 6, 2025, at 7:20 a.m., the driver of Unit #1 reported that they were traveling south on Bypass 4. Upon reaching the turnaround, located 620 feet south of the intersection with Symmes Road, they made a left turn from the far lane to head north on Bypass 4. The driver alleged that Unit #2 took the turn too wide, resulting in a collision with Unit #1. The driver of Unit #2 stated that they were also traveling south on Bypass 4. At the same turnaround, they made a left turn from the curb lane to head north on Bypass 4. The driver of Unit #2 claimed that Unit #1 cut the turn too tightly and entered their lane of travel, leading to a collision with Unit #2. 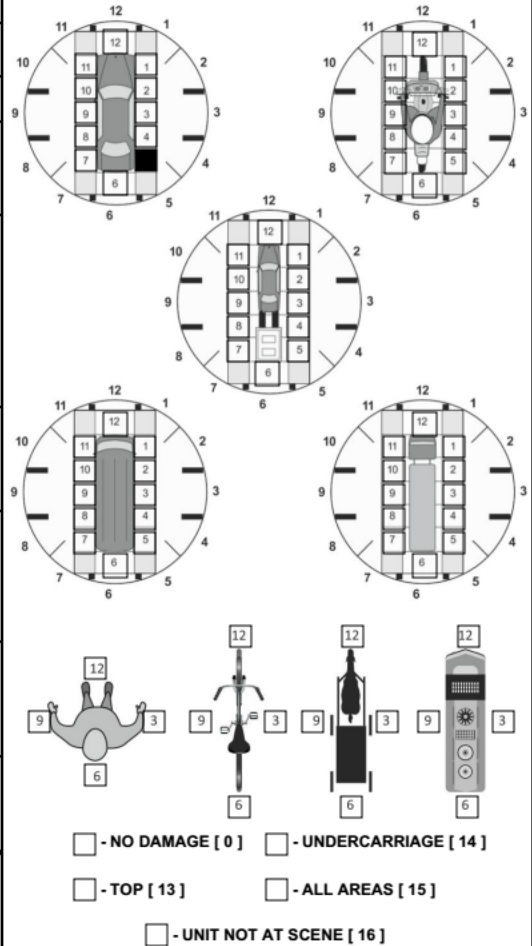
