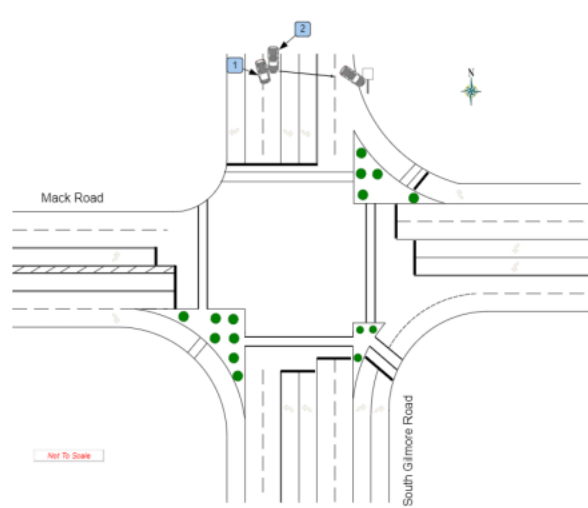

NARRATIVE On 10/29/25 around 0753 Unit 1 was traveling south on South Gilmore Rd. near Mack Rd. when Unit 1 failed to maintain marked lanes of travel and switched lanes without asserting that such movement can be made with safety. Unit 1 then struck Unit 2 who was also traveling south on South Gilmore Rd. When struck, this caused Unit 2 to cross the center line and strike a road sign on the opposite side of the roadway. 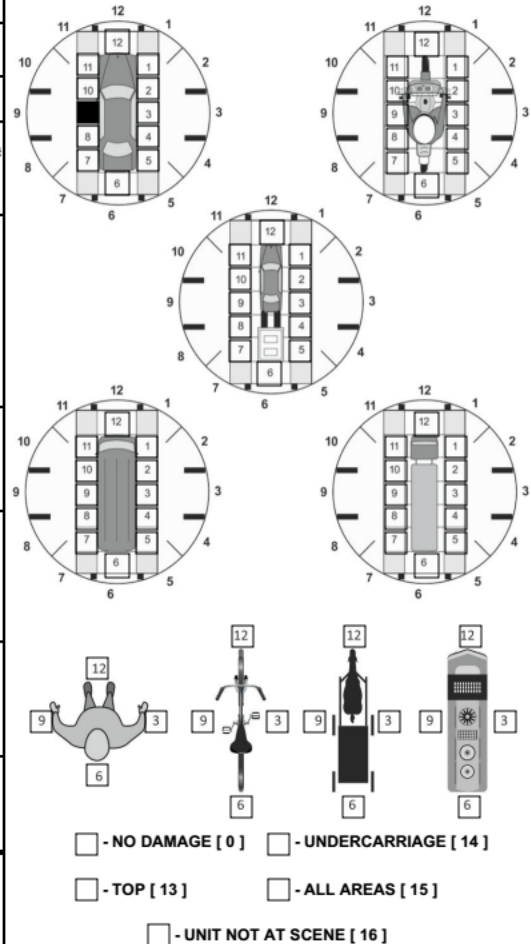
