Unit 2 was clearing the intersection after getting a red light and attempted to turn left onto Winton Rd when Unit 1 ran through the red light causing Unit 1 and Unit 2 to strike each other. The independent witness stated that Unit 1 ran the red light as Unit 2 was trying to clear the intersection.

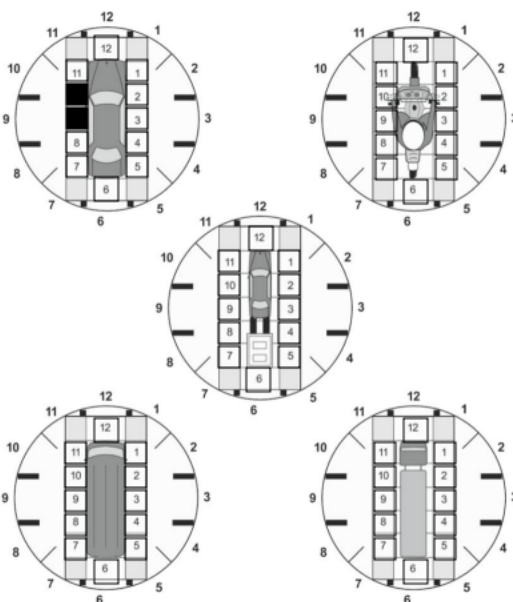

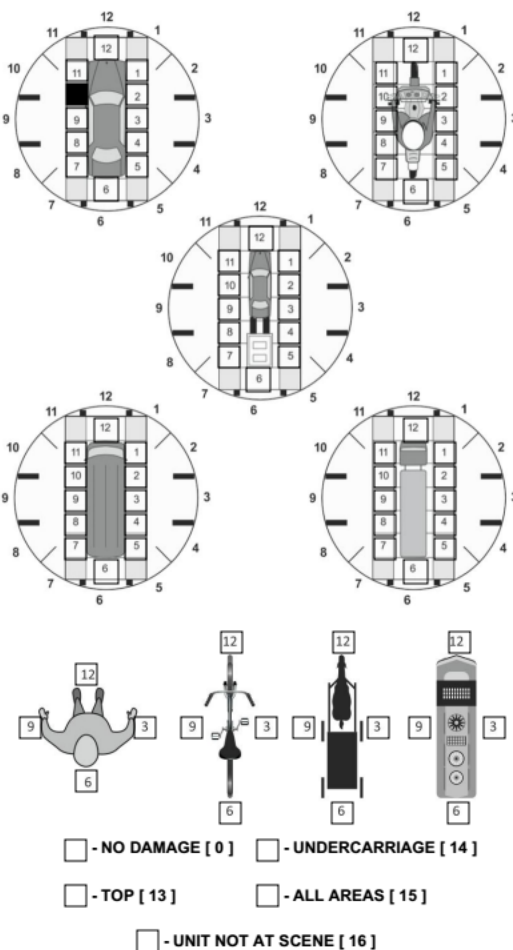
