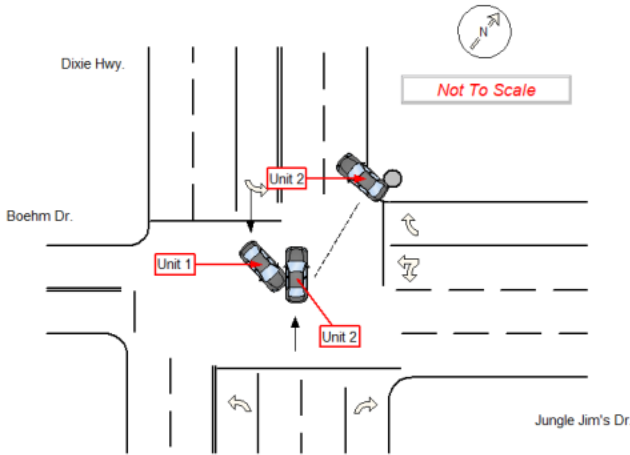

Unit 1 failed to yield to unit 2 and struck unit 2 in the driver's side causing unit 2 to hit a traffic light post causing damage to the rear of unit 2. 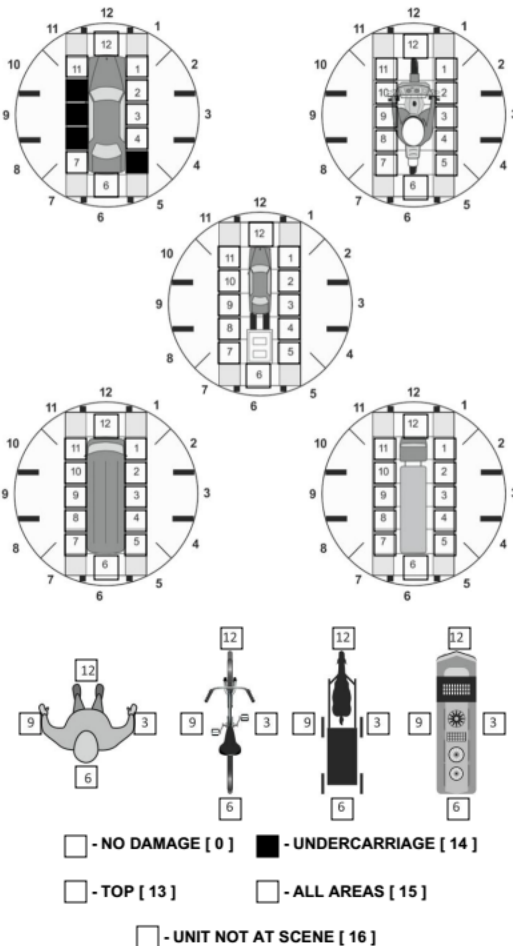
