NARRATIVE On January 28, 2024 at 3:15p.m Unit 2 was traveling east on Mack Road in the left lane. Unit 1 was also traveling east in the right lane, directly next to unit 2. Unit 2 stated that unit 1 came toward her lane, striking her vehicle. Unit 1 claimed that unit 2 had been driving recklessly and caused the collision. 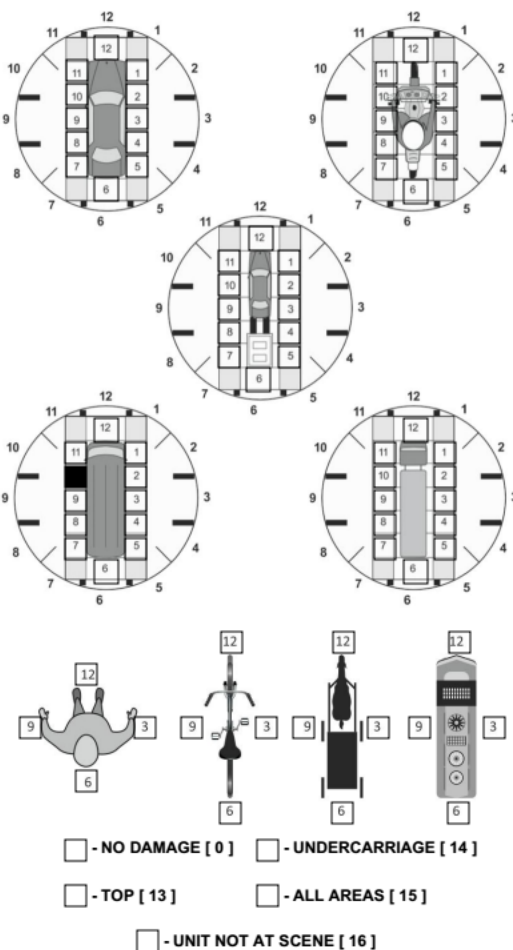

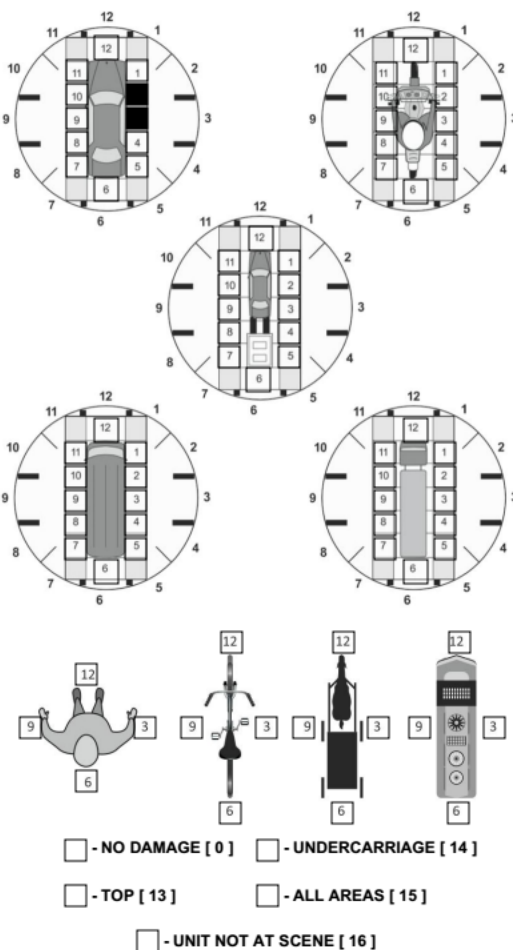
