

Unit 1 was traveling north bound on US 127 at approximately 10 M.P.H. and when at 5350 Pleasant Ave. (US 127) failed to stop within the assured clear distance ahead and collided with Unit 2 which was also north bound and was stopped in traffic at 5350 Pleasant Ave. Brake lights on Unit 2 were inspected and were working properly.  Unit 2 was towing a 2004 18 foot Crestliner Canadian boat. Unit 1 struck the boat which caused the trailer of the boat to be pushed into and damage the bumper of Unit 2. 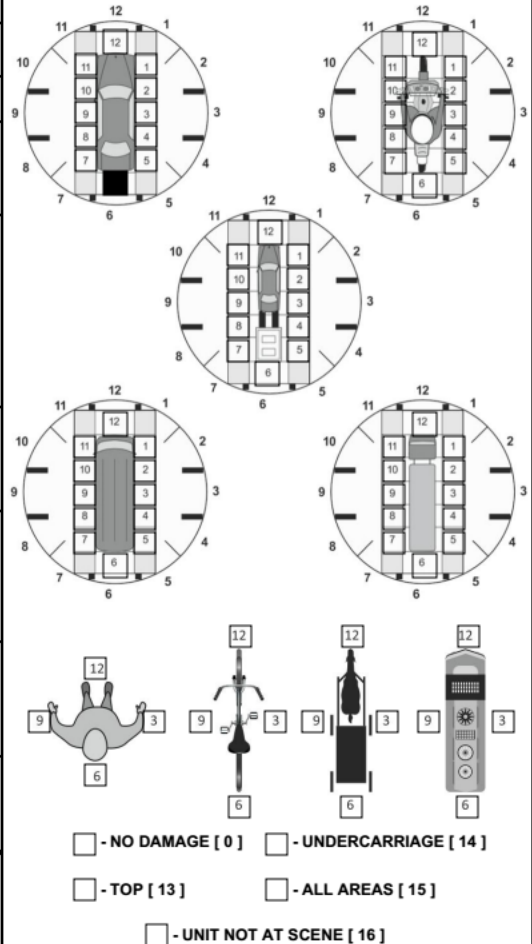
