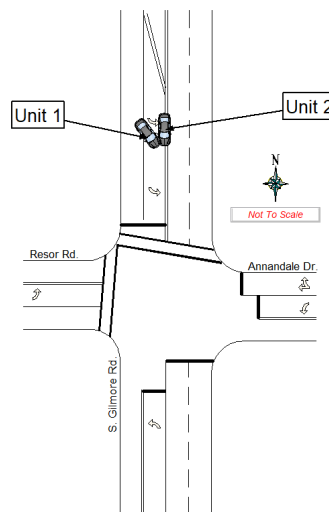
NARRATIVE

The driver of Unit 1 stated that he got into the left turn lane to go around that crash when Unit 2 went around him by crossing the double yellow lane causing the Units to strike each other.

The driver of Unit 2 stated that she was already in the left turn lane and Unit 1 changed lanes and struck the passenger side of Unit 2

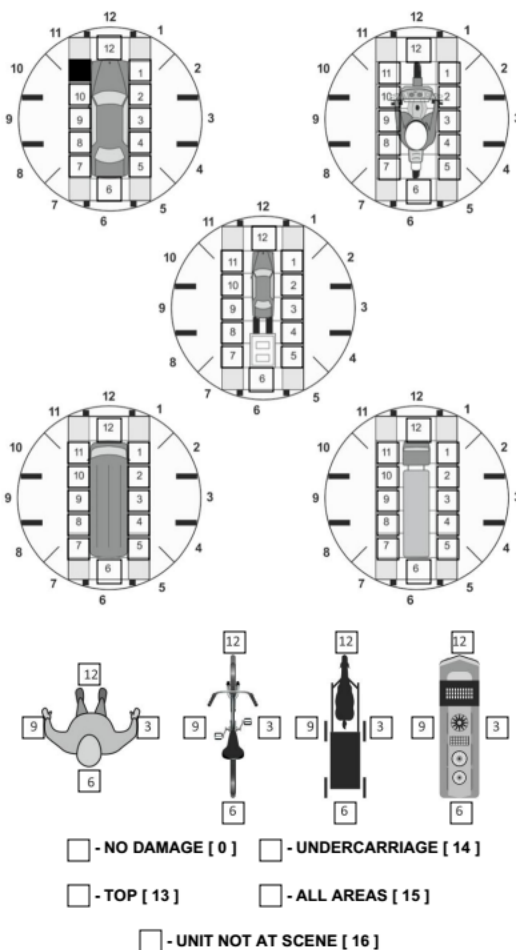

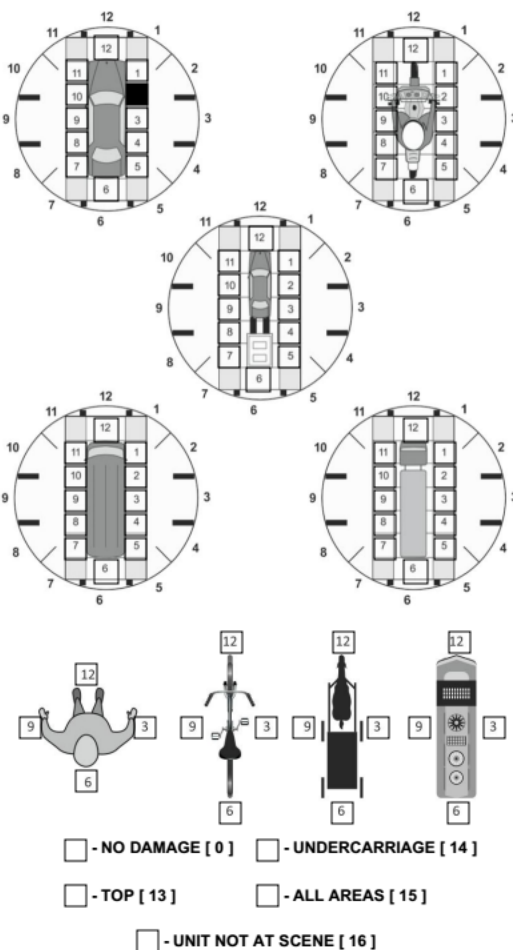
