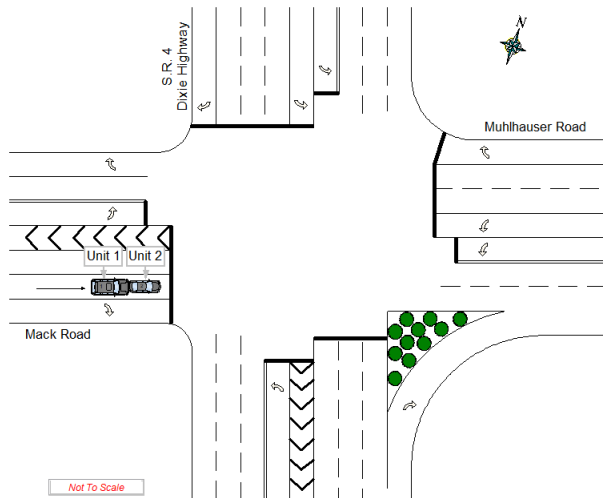

ON 2/21/24 AT 3:11PM UNIT 1 AND UNIT 2 WERE BOTH TRAVELING NORTHEAST ON MACK ROAD STOPPED AT THE INTERSECTION OF MACK ROAD AND DIXIE HIGHWAY. WHEN THE LIGHT TURNED GREEN, UNIT 1 STARTED TO ACCELERATE BEFORE UNIT 2 STRIKING UNIT 2 FROM THE REAR.
