NARRATIVE On 03/05/2024 unit 1 was traveling from the east on Port Union Rd. attempting to make a left turn onto Holden Blvd. and go south. Unit 2 was traveling from the west on N. Gilmore Rd. making a right turn on Holden Blvd. to also go south. Unit 2 stated that the light was green when they both turned onto Holden Blvd. striking each other on their respective driver side and passenger side of their vehicles. Unit 2 stated that unit 1 then turned and went north on Dixie Hwy. without stopping. Unit 2 described the vehicle as a white Dodge Charger. Through further investigation the hit skip vehicle and driver were located. After interviewing both parties I am unable to determine fault. Both parties stated that each unit came into their lane. 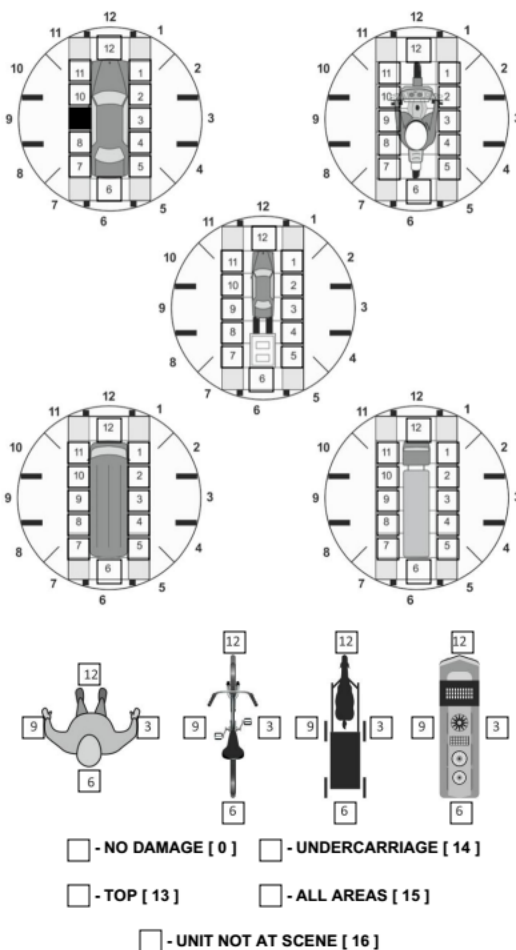
