

Unit 2 had the green light to proceed through the intersection. Unit 1 failed to obey the cross walk traffic control device, and in doing so, failed to yield the right of way to traffic and was struck by Unit 2. The operator of Unit 1 was ejected from the motorized bicycle. The operator of Unit 1 was treated on scene by Fairfield Medics and transported to UC Medical Center in Cincinnati by UC Air Care. 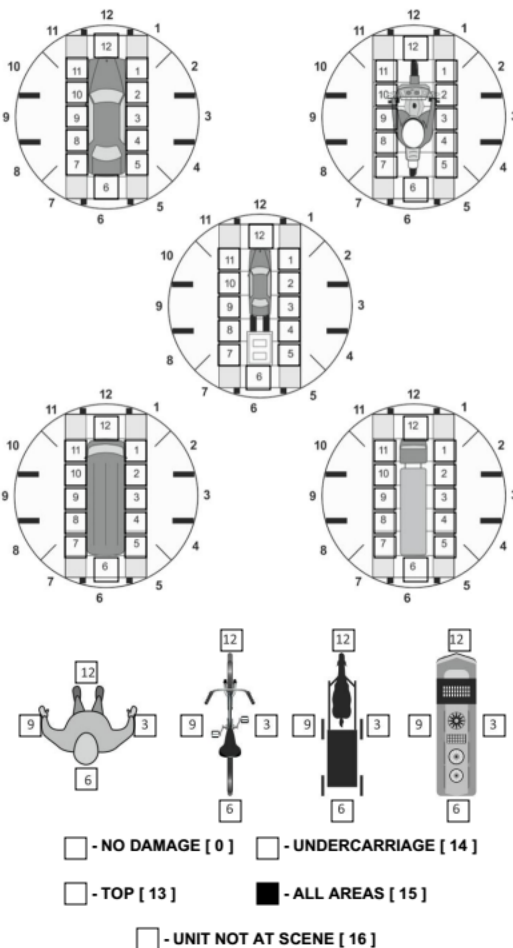

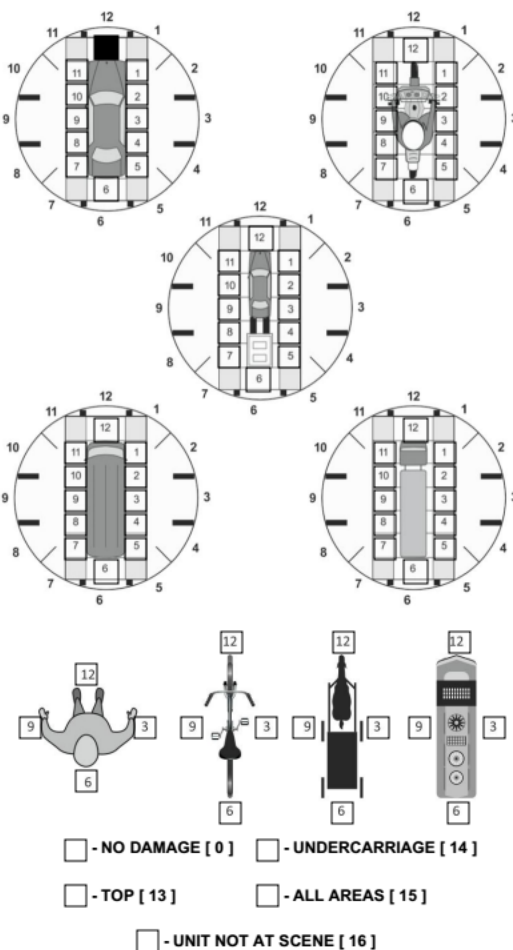
