When asked if either party had injuries unit 2 driver stated he "sprained" his neck, and described it as a "little backlash". He declined a medic, and stated he would get himself checked out. 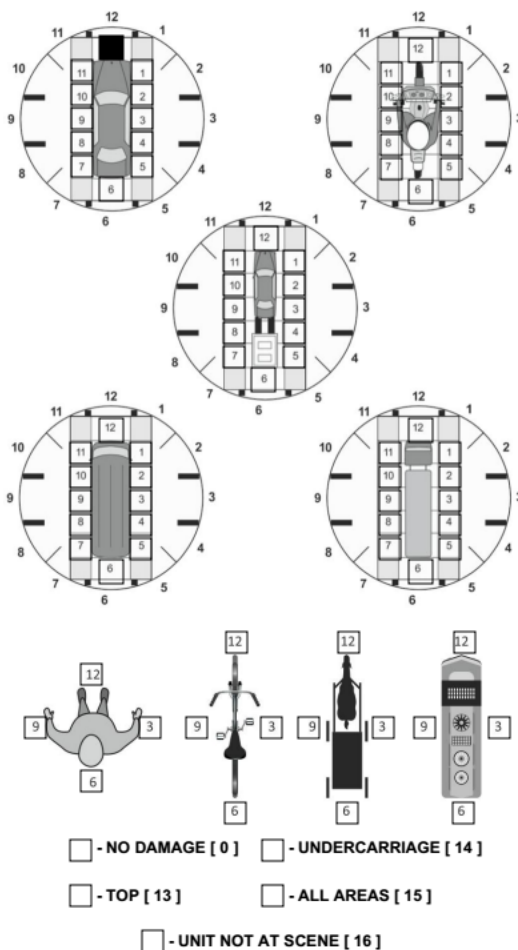

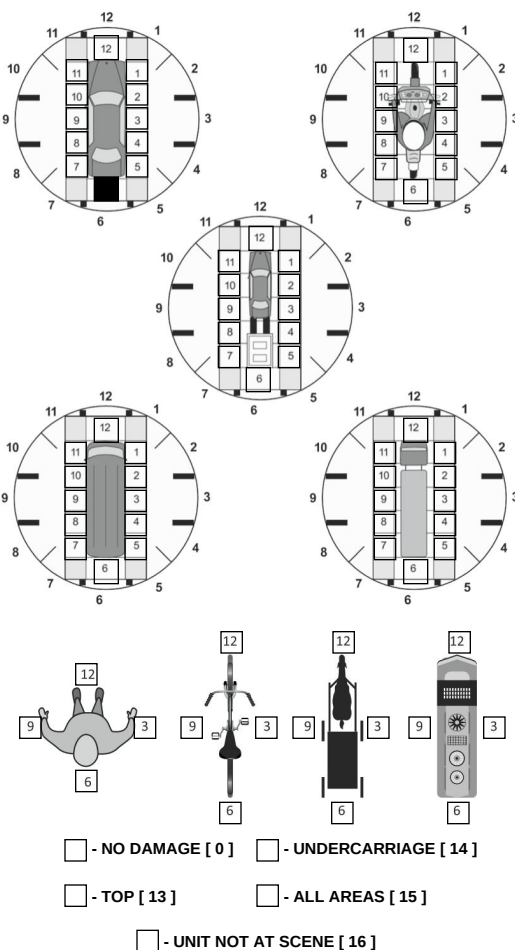
