Unit 2 was stopped in traffic at the red traffic signal at SR 127 and Nilles Rd. facing north. Unit 1 failed to maintain assured cleared distance ahead and struck unit 2 in the rear. Unit 1 driver was found to be impaired by alcohol and arrested for OVI. Unit 1 driver was charged with ACDA, OVI and OVI high tier. Unit 2 refused to provide insurance information.

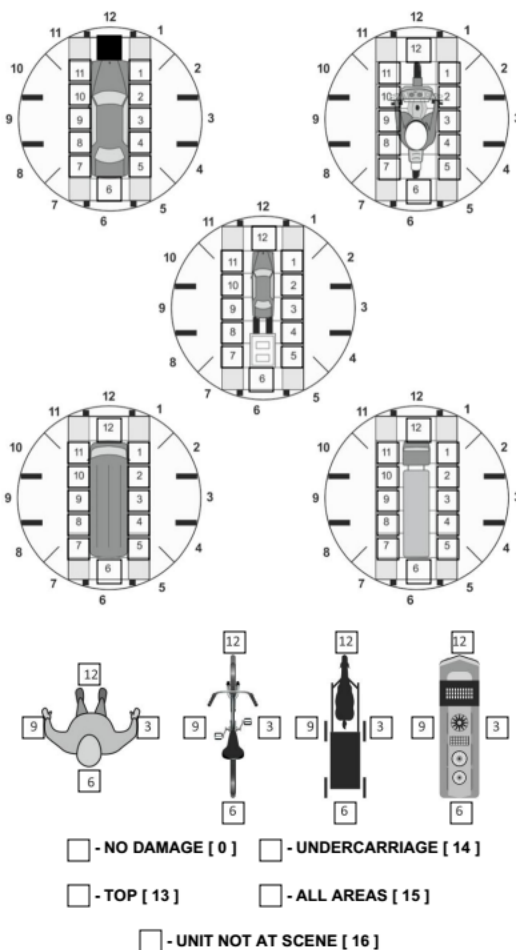

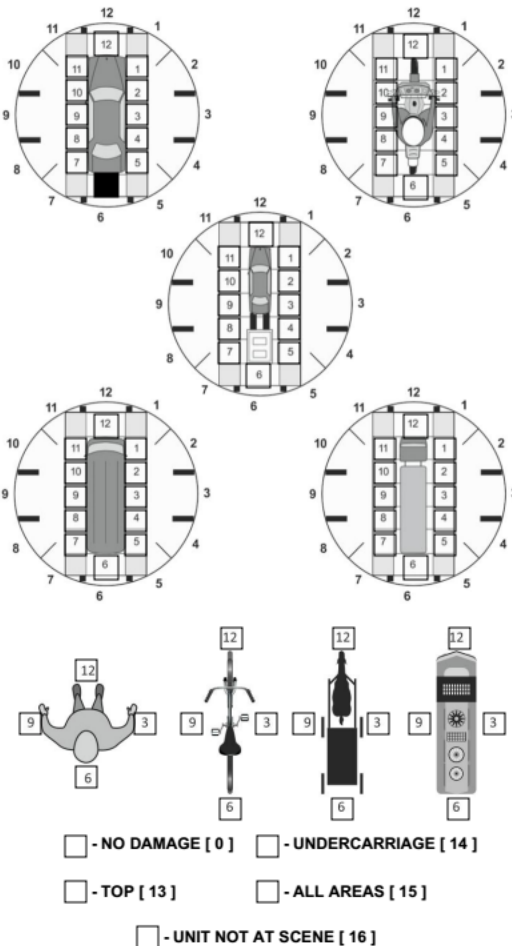
