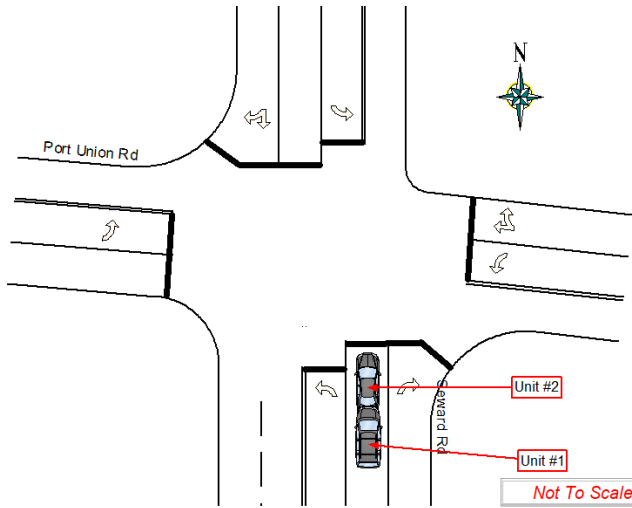

The drivers of the two units spoke after the crash. The driver of unit #1 stated he was under a driving suspension and did not want the police to tow his car then left the scene. 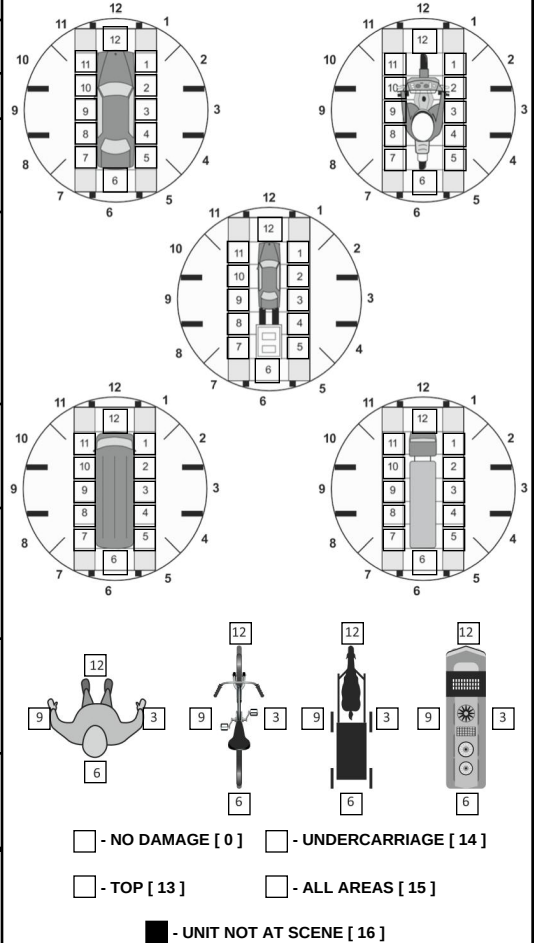

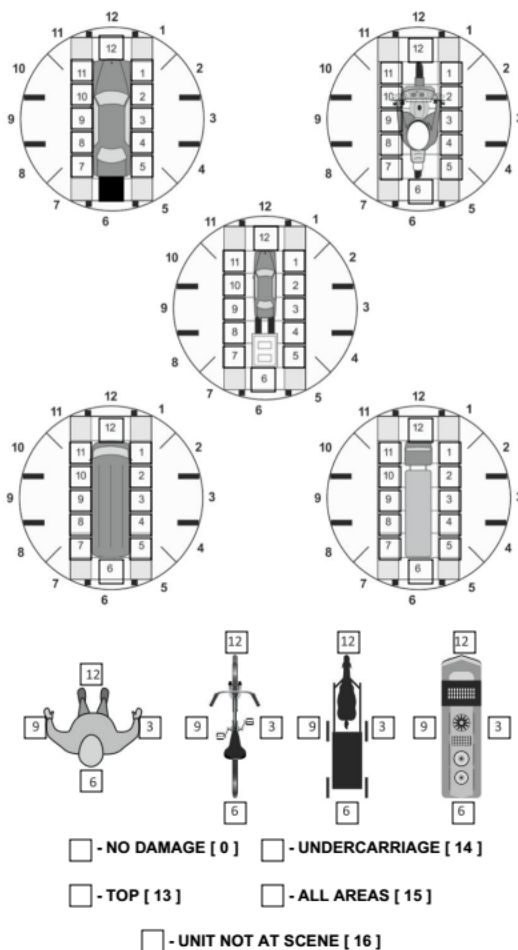
