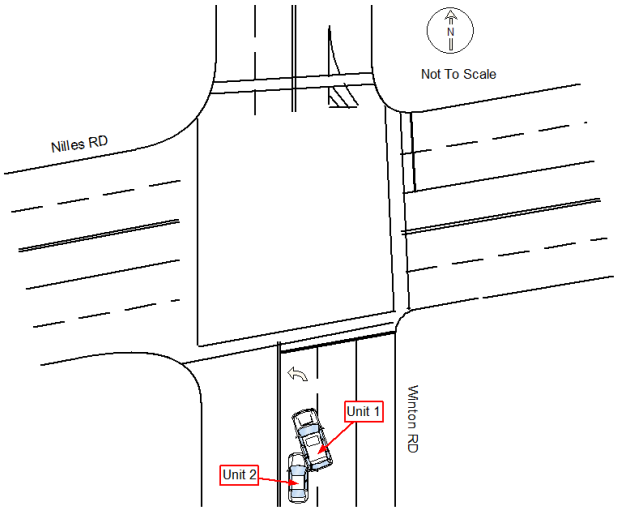

NARRATIVE On 4/4/2024 at around 4:01 P.M. Unit 1 stated they were traveling northbound on Winton Road at approximately 35 M.P.H. and when at Nilles Road got into the left turn lane. Unit 1 states Unit 2 was behind her and also traveling northbound on Winton Road. Unit 1 states Unit 2 went into the median before getting into the left turn lane and sped up and in so doing struck her when Unit 1 got into the turn lane. On 4/4/2024 at around 4:01 P.M. Unit 2 stated they were traveling northbound on Winton Road and when at Nilles Road Unit 2 got into the left turn lane. Unit 2 stated that Unit 1 was in front of Unit 2 and continued to travel in the center thru lane but at the last second got into the left turn lane and in so doing struck Unit 2 which was already in the turn lane. 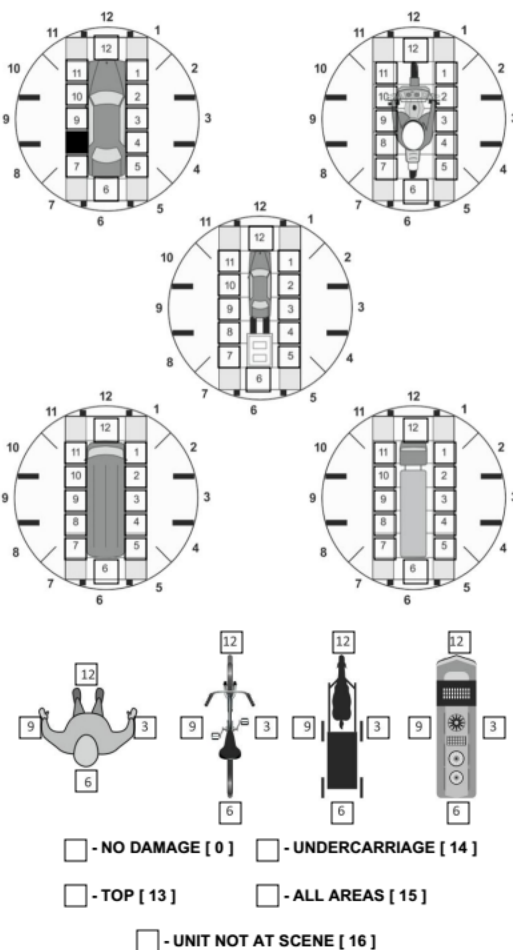

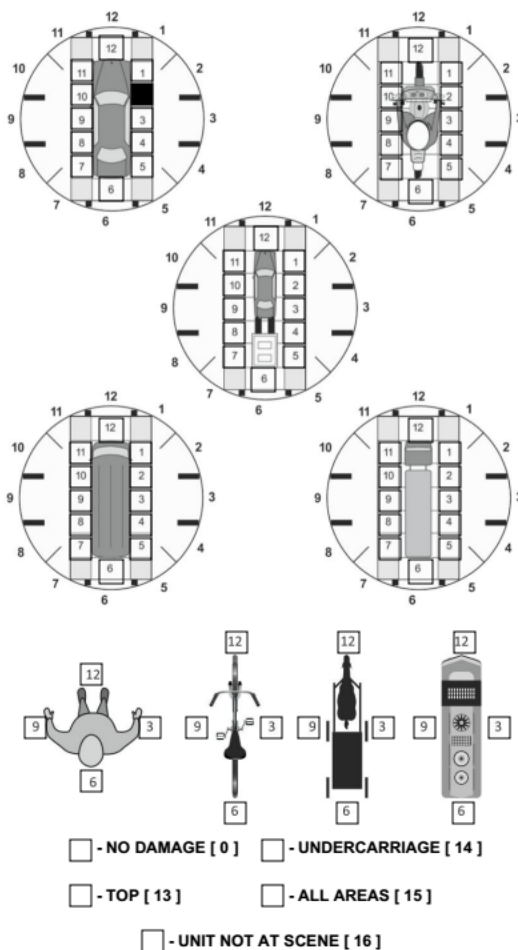
