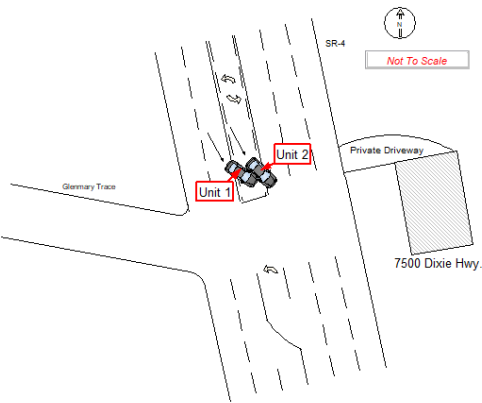

NARRATIVE On 04/11/2024 at about 4:12 p.m., unit 1 was traveling southbound on SR 4 near 7500. Unit 2 was also traveling southbound on SR 4 near 7500. Unit 1 made a left hand turn into 7500 and in doing so, struck unit 2 on it's right passenger side. Unit 2 was also turning left into 7500. Unit 1 driver claimed he was in the left hand turn lane and said unit 2 went around him to turn into 7500. Unit 2 driver claimed that the unit 1 driver was not in the turn lane, but instead in the southbound lane of travel on SR4. Unit 2 said he was in the turn lane to turn left into 7500 when unit 1 struck his passenger side. Due to the conflicting stories, neither unit was cited.					DIAGRAM

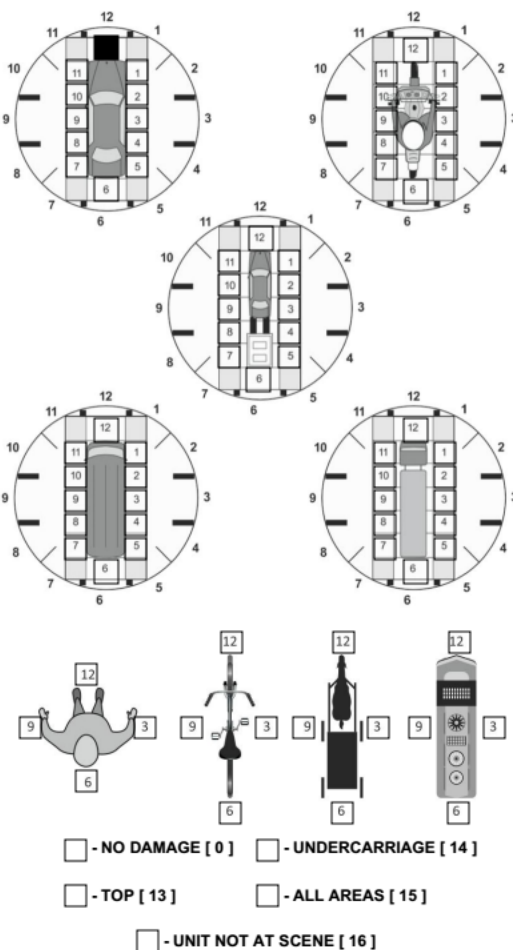

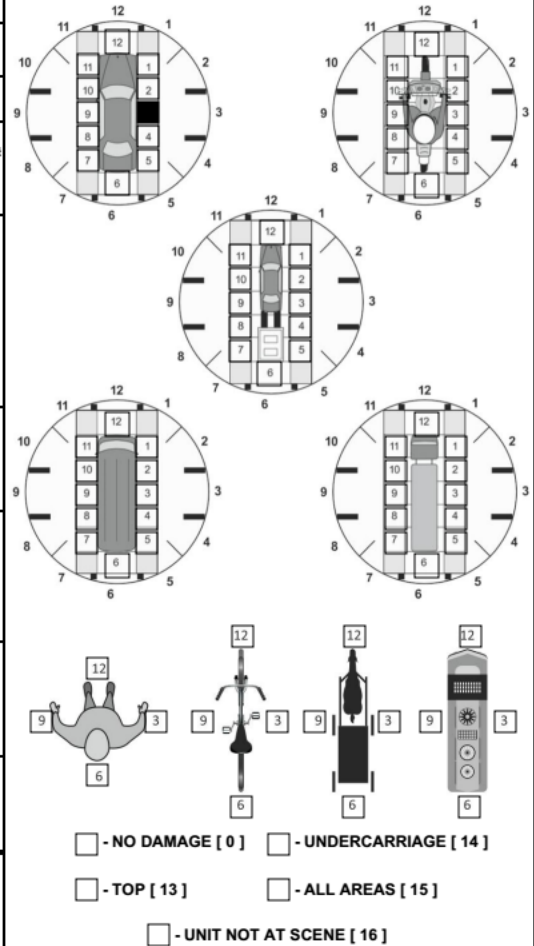
