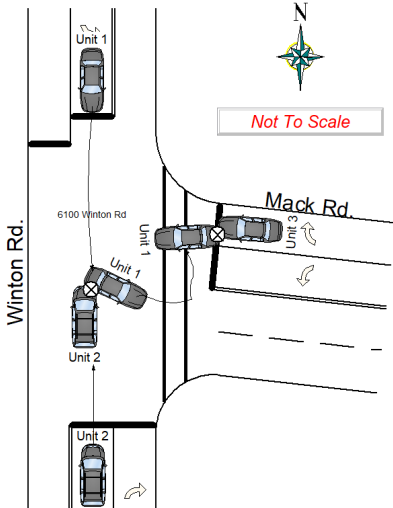

Unit 1 turned Eastbound in front of Unit 2, causing the Units to collide. The collision caused Unit 1 to collide with Unit 3. Unit 1 failed to yield to the northbound traffic, causing the crash.
